A hybrid free press

We will still have a free press sniffing out stories. However, the Sub-Senate's channel and its Ubiquitous recognition and money, together with the industry fragmentation requirements will change the nature of journalism.

1/ No longer will any large news feed have the most credibility. The million-man Sub-Senate's feed will have the most cred.

2/ Journalist careers will be measured in a much different way.

Free speech and money court

1/ When speakers drive their audience towards violence, the only way to punish them is in criminal court.

Their accusers shall have no and no right to pursue the matter in money court.

2/ Money court shall be prohibited from trying any matter related to free speech about government, elected people, famous people, leaders, the economy, public policy, elections, corruption, or group decisions.

Inciting violence

With regard to our first and foremost right of free speech, liberty shall always be more important than public order.

The bar for the definition of inciting violence shall err on the side of liberty with regard to free speech. If there is doubt, the speech shall be permitted. The call for violence or crime must be clear and literal. Vague, indirect, and figurative words and language shall not count.

Talking about the other candidates

It is quite important that we eliminate all the downside of Senate service. And one of the big downsides is other people saying negative things about you because you are their election opponent. So we will say this: If any Senate candidate is talking about the other candidate (s) each of us should consider them disqualified on that fact alone. And while this is an official policy, it is not enforced by government, but by each of us. We do this because we don't in any way want this sort of rumor-mill corruption in our elections because of how quickly it drives good people away from democratic service.

Publishers and rights

No agreements between writers and publishers, or distributors shall exist for more than half the remaining IP period at the time of signing.

Fictional citizens are second class citizens

1/ There shall be no right of free speech for fictional citizens when it in any way diminishes the ability of real flesh and blood citizens to hold a public dialogue.

2/ Fictional citizens shall have no right to earn a premium on assets condemned by the public.

3/ Free speech being a thing of real flesh and blood people, all fictional citizens, shall:

a/ Be required by law to tell the truth, the whole truth and nothing but the truth, and not in a sneaky or relativistic way.

b/ Be prohibited from uttering any opinion, judgement, innuendo or analysis of news events. They may only report facts, and they must be unbiased in this duty.

c/ Shall pay business crippling toxic-waste sized fines for polluting the public discourse.

Voting age

For voting to be valid

1/ Each ballot box stays put and is watched and counted by a long line of people from that district, as many as care to count it.

2/ All ballot boxes must be under continuous public supervision and uninterrupted video livestream.

3/ Everyone putting a ballot in a box must be recorded and all ballots must be verified to be single.

4/ There must be a verification system for government ID + fingerprint + photo + face recognition. This to keep foreigners from voting and also to keep people from voting more than once.

5/ Voting all at once, in one hour, prevents multi-voting. But because of this, we need small voting districts.

6/ The right of the democracy to be free of voter fraud is all important.

7/ The people must have the right to monitor and record their elections and the counting system.

Voting priorities

1/ No hidden places for ballot boxes to be changed out.

2/ Only citizens vote.

3/ Nobody casts more than one ballot.

4/ Counting by a long line of people.

5/ The difficulty of registering or voting does not matter much in comparison to the things above.

6/ Cost and convenience do not matter in the slightest bit in comparison to election honesty.

7/ The ballot box and counting corruption is normally a bigger problem than vote selling and voter intimidation.

Census questions

1/ The head and shoulders first reason for government to hold a census is to double-check and verify voter "inventory" by parallel process. This is to keep people from adding phantom voters as a means of corrupting our democracy.

2/ It is quite useful to have a parallel-process double-check on non-citizens. This way we have a good idea about how many non-citizens are living in our country. This is also useful in locking-out phantom untaxed foreign workers.

3/ A 10 year census is a silly idea, a non-census. The Census should be annually or perhaps 10X per year to be an effective means of measuring the electorate and locking out illegal aliens.

We the people

These are the first 3 words of the US constitution. These three words say very clearly that power rests with the people, not the government the people establish for themselves.

How to make everyone's home safe

The maximum penalty for shooting a stranger in your home in 5-years of community service. Workers and some other people may be considered strangers when they come back.

Police shall not handcuff cooperative people 8 and younger, women over 72, and men over 75. Those under 12 and over 68 get cuffed hands in front.

Eliminating bad religions

In the land of the free, we automatically start with allowing all non-violent religions to be practiced. However, when the religion turns violent, or terroristic, conspiratorial, or inverted, or it harasses apostates, or it is used for nefarious purposes like sex with children, or funneling money — its practice should be curtailed whatever means the Senate finds expeditious.

The freedom of religion is a secondary and limited right

Freedom of religion is far less important than many other rights like freedom of speech, freedom to assemble, and the freedom to be armed... among numerous other freedoms. And certainly, one's freedom of religion comes with no right to demand anything at all from the non-believers you share your pluralistic society with. You are free to practice your religion in peace, but the moment you ask anything at all from non-believers, even that the

merely listen to you, you are no longer practicing your religion in peace.

Religious freedom and sexual identity

One is free to have whatever religious beliefs and sexual identity one wants, but one is not free to ask anything at all of other people. If they don't want to recognize that you have god's true message, that is their option. Likewise if they don't want to recognize you as a woman, that is their option. Also, if you are even somewhat insufferable for either reason, you should have no right to cry discrimination because people think you are a kook.

If you are a transvestite

- 1/ There shall be no advertisements.
- 2/ There shall be no mention in the media.

Non-citizens and discrimination

Non-citizens are not allowed to make claims of discrimination based on nationality or on being a non-citizen.

Ponder government secrecy

It is mostly a 4-headed creature:

Head-1: Secrets of weapons, plans & tactics.

Head-2: Secrets of the justice system.

Head-3: Secrets of the political system.

Head-4: Secrets of group spending.

There are many secrets of the 1st head that are acceptable under certain conditions. And witness protection programs are a thing of the second head that should be allowed. However, all the other secrets of the four head should generally be regarded as always bad. •
• • Senate orientation should explain this subject well. Government workers should never work towards secrecy, except with regard to military secrets, plans & tactics, and witness protection programs.

Senators may carry arms

All Confirmed Senators shall be automatically licensed to carry a firearm without approval, once they have completed the gun safety and security module.

R'20.8

All break-down-the-door search or arrest warrants must be preceded by at least two seconds of loud police siren so those inside will know that it is the police and not criminals.

R'20.9

Government shall have the right to show up and inspect all premises offered for sale or rent, as well as all unoccupied areas under construction, and construction areas where the door left unlocked. Government shall also have the right to inspect all property sold or rented within the prior 3 days.

R'21.6 Police may shoot those firing arms at them, those pointing a firearm, or firearm simulation at them, those in firearm pointing stance directed at them, and those who are raising or turning what looks like a firearm to point at them. Police shall also be free to hold, draw and point firearms at those reaching for possible arms.

Once someone fires on police, they may be shot. Shot even if they are running away, for they may turn at any time and fire. They may be shot even if they have thrown their gun down, and are not hands up, because they may have a backup gun.

Once a person has fired on police, the only safe position is hands up, back to the police.

Everyone should be taught the police rules.

You must cooperate with your own arrest
Everyone must put their hands in cuffing position.

DMV vehicle registration

Before you drive a new vehicle, you must use the DMV app to send the license plate in.

For vehicle stops

One's driver's license, registration, and insurance, along with one's driving record should be available to police by car license plate number read by image scan from the camera on the front of the police car, and also by keypad entry and by voice entry. When you get stopped, the license plate gets run and the name of the registered owner and all registered drives comes up on the cop's tablet. The cop already knows the name of most potential drivers, their violence history if any, their photos, their names and their driving history. There is no longer anyone reaching into glove compartments to get anything. So the officer walks up to the window of the car and has a number of potential drivers of the vehicle. He picks the one most likely people and says "Are you John Smith?" you say yes. He clicks your image and then the system generates a receipt. Then the cop hands you the receipt and 20 minutes after he has sent in the charges (selected from a long detailed restaurant menu of offenses) the you get the charges via email.

The rights of the dead and dying

08.5) This should read: "Those who have inherited community property in a marriage may not leave community property to another".

09.13) Government shall not charge when the county recorder holds and disburses money for minors and 20-somethings as instructed by the wills of their parents.

09.14) All gift and inheritance tax shall be payable to the nation/ state where the deceased made most of his money in, not where he later moved to. If this is a large sum and multiple locations are involved, then the money shall be apportioned appropriately.

09.15) There shall be a 95% tax on all contributions to religions made within 10 years of death or at any time after death.

County governments cannot elect not to enforce national laws.

Where sub-government must cooperate

- 1) Tax collection
- 2) Criminal investigations into sub-government
- 2) Enforcement of national government's criminal law system.
- 3) Immigration and illegal aliens.
- 4) Wherever specifically demanded due to the logistics of emergency.

Freedom of speech

No fictional citizen, employer, school, charity, religion, club, political party, or other association of man shall be allowed to punish or discriminate against their members/ workers/ associates for any political speech that government cannot punish a person for. If any of these strips a flesh and blood person of their status due to their legitimate exercise of free speech, the fictional citizen may be required to pay toxic waste sized fines. The idea is to get fictional citizens to stay far away from each citizen's right of free speech.

Free speech and little brother

- 1/ Employers shall never be free to discriminate against their Employees for what they say in their free time, or in their personal communications. To allow this is to undermine our first and foremost right to free speech.
- 2/ Service providers such as airlines and social media shall never be free to discriminate against their customers for their legitimate free speech, or in their personal communications. To allow this is to undermine our first and foremost right to free speech.
- 3/ Employees shall generally not be free to add their own sexual, economic, or political messages to their work conversations or attire while at or around their workplace property. However, where employees are free to wear whatever clothes they want, or to have exposed tattoos, it is inconceivable that they are not allowed to express political views on their clothing, even if this goes against the beliefs of their employers.
- 4/ Workers shall generally not be permitted to divert customers and co-workers to competitors, or to their own personally profitable ends. However, workers shall be free to inform customers of different and much less expensive approaches. Also, workers shall be free to inform customers of genuinely abusive billing tactics, poor practices and shoddy workmanship.

Cruelty to animals

Invertebrates, reptiles, amphibians, poultry, and rodents shall not be protected by any animal cruelty laws.

Freedom of Assembly

R'2. FREEDOM OF ASSEMBLY

- 1/ The freedom to assemble is the second citadel right, ahead of all other rights except the right to free speech.
- 2/ The right of the people to assemble, protest, muster and re-muster shall not be denied or substantially re-directed by government. The Senate shall be required to obey a 66% over-majority of voters mustered under a new constitution.
- 3/ Government shall not prevent or hinder the people from assembling in a more-or-less peaceful way to hear speakers, discuss issues, organize, protest, or muster up into a new broad democracy.
- 4/ Large assemblies of the people shall be held in parks, squares and minor streets, and not in places intended to obstruct the functioning of society, such as airports, transit hubs, arterial streets, trials, hearings, or market centers. Protesters that intentionally obstruct the functioning of society may be jailed and fined. If an assembly overflows from an out- of-the-way location and obstructs the functioning of the community, the next assembly of that group must be held in another location where this will not occur. Except for reasons of public safety and obstruction of the functioning of society, and the separation of counter protests, government shall have no say over where the people protest.

5/ The right to assemble being so fundamental and vitally important to the cause of freedom, government shall never disband assemblies of the people unless on that very day a significant percentage of the assembly turns to bloodshed, or arson, or the threat of this

6/ Peaceful protesters shall consider it their obligation to freedom to oust the violent from their protests by finger-pointing and opening to allow law enforcement in to arrest the people so pointed out. Peaceful protestors shall also consider it their duty to freedom to record all violent acts, and to stand witness against the perpetrators in court.

7/ Everyone shall keep in mind how the opponents of protesters do sometimes send people to join and infiltrate protest and cause violence in the protest's name, frequently as an excuse for disbanding or besmirching the protest. When people who are, or recently were, strongly affiliated with the opposite side infiltrate a protest and cause violence in the name of the protest, this shall be considered democide.

8/ Security forces at demonstrations exist primarily to protect the people from injury to life and limb. Non-fire damage to property really doesn't really matter in comparison.

9/ Police may wear helmets and transparent face shields during protests, however, no police or protesters shall mask their faces during protests or wear a uniform that makes one protester hard to distinguish from another. All police at all protests must wear their number front and back in 4-cm characters.

10/ During protests, it shall be a principal obligation of police to detain those ousted by the mass of protestors for acting violently, or threatening violence.

11/ It shall be recognized by all, that maintaining order during protests is the most critically important role of police officers in a democracy, for this is where their actions also have a political dimension.

12/ Those violating the rights of a peaceful political protest, especially those injuring or intimidating peaceful protestors may be charged with democide, even if lone individuals, even if under order by a superior officer, even if acting on their own, even if acting in great numbers, and even if this new constitution was not yet in force. And again, those on the opposing side, who infiltrate a protest and cause violence in the name of a protest to smear the protest may also be charged with democide.

13/ Our new one-size-fits-all prototype democracy for the entire world must heed how so many armies have brought so many murderous dictators to power from Julius the Seizer to Adolph Hitler with thousands of others in between. Our democracy and its warriors shall not take the intimidating power of men-in-arms lightly, and for this reason, the military shall be strictly prohibited from having anything to do with political matters, especially political meetings and protests of the people. Only police and civilian militia may secure political assemblies and protests of the people. All military men shall be duty-bound to disobey all commands to attend such a meeting,

if it ever is ordered, just as they are duty bound to disobey a command to fire on their own people. Any military commanders ordering their forces to act upon, secure, or intimidate political assemblies and protests of their people may be charged with democide.

14/ At political protests, to assure that everyone is on their best behavior, there shall be triple penalties for unprovoked crimes, and double penalties for over-reactions.

15/ There shall be no open flames, lighters, matches, or smoking at protests. No fire, and no fire-starters or accelerants.

16/ Government may only disband assemblies of the people for activities that occur on that day, and then the assembly shall only be disbanded for the remainder of that day.

17/ There shall be no concurrent counter protests within 5-km of any protest.

18/ There shall be no limitations or penalty for the words spoken or disseminated at an assembly of the people, except that it shall be a crime to call for domestic violence, or to attempt to re-direct domestic violence that is already occurring.

19/ Only citizens able to vote may attend, participate-in, organize, or fund political assemblies and political organizations. It shall be considered voter-fraud when non-citizens, and provisional citizens try to participate in our democracy either by their physical presence at a protest, or by their aid or donations of money. However, visitors and immigrants shall be generally free to write about public policy, so long as they don't call for violence or revolution, and they disclose that they are non-citizens at the start and end of their work.

20/ The rights of free assembly and free speech shall not apply to those who seek to dissolve democracy or do away with our freedoms. Those who advocate dictatorship, totalitarian government, monarchy, constitutional monarchy, constitutional presidency, theocracy, sharia law, totalitarian government disguised as religion, Nazism, fascism, oligarchy, the killing of other races, lynching, or the short-circuiting of due process shall have no right to assemble or protest.

21/ All news reporting of protests shall include drone images that show the true scale of the entire protest from above. This shall accurately estimate the number of protesters. News reporting must also show the faces of the people protesting so people can judge if the protesters character.

22/ The right to assemble is a political right that shall not be diminished-by, or confused-with, riotous celebration, or protest of events that are not political, or economic. This constitution does not guarantee the right to assemble in great numbers to celebrate or protest matters of sport.

23/ Offering or accepting money, or anything of value, including alcohol, food, and sexual favors to engage in a political protest shall be considered the felony of vote

buying. Those purchasing multiple protesters, along with their conspirators shall be penalized for each protestor purchased, and after just a few protestors may end up spending the rest of their lives in prison.

24/ When visitors and immigrants unable to vote in our elections attempt to participate in our political process, or participate in protests, or picket, or speak in person to an assembled mass of people in our land, it shall be considered the felony of voter fraud. This item 24 shall not apply to anything said overseas, or anything in writing, or those invited or allowed by the Senate to speak in our nation. This item 24 shall however apply to non-voters who go around talking to dozens of small groups campaigning for a cause in our nation.

25/ Threatening people with violence for protesting or expressing their political views shall be a felony with up to 10-years in prison per count.

Arms

"Among the many misdeeds of the British rule in India, history will look upon the act depriving a whole nation of arms as the blackest."

R'3. THE RIGHT TO BEAR ARMS

1/ A strong well-armed people being necessary to the long-term security of a free and democratic nation, the right of the people to keep and bear arms shall not be infringed except as described in this Rule R'3.

2/ Our nation shall always look at the big-picture, and the long-term historical picture on firearm ownership. It shall realize that limited amount of death caused annually by internecine gun violence is thousands of times smaller than the life-savings that firearms bring in cases of invasion, seizure of power, warlordism, mafia violence, crime gangs, and general crime.

3/ Only citizens eligible to vote in this nation's elections shall be allowed to own or hold firearms. It shall be a felony for non-voters to hold firearms in our nation.

4/ Those previously convicted of a felony shall not have the right to own or hold firearms unless they are temporarily granted the right to hold arms by the Senate due to a national emergency.

5/ Those who have not completed secondary school in our nation, or passed the secondary school equivalency exam in our nation and its national language of English shall not own or hold firearms.

6/ It shall be a felony to possess a firearm that is not registered, or does not match the ballistics registry.

7/ The right to bear arms is based on the fact that firearms are more effective defensively than offensively. Firearms clearly favor the honest and static majority over the dishonest and ravaging few. The defensive power of firearms shall not be reduced by any purchase waiting

period. However, no firearm shall be sold when the buyer appears to be angry, agitated, drunk, or high on Mafia drugs.

8/ There shall be two classes of projectile weapon, civilian and militia. Civilian weapons shall not explode, except to fire projectiles through a barrel. Civilian weapons shall also not have a barrel larger than 2-cm in diameter.

9/ Some civilian weapons should be high powered and have armor piercing bullets. It is important that the people have adequate arms and means to defend against oppressors using armor. However, the ability to rapidly fire large numbers of unaimed bullets in some general direction should be considered sloppy for civilian weapons used in a community. We shall require that all shots from civilian weapons be aimed. And we shall accomplish this by limiting the fire rate to one shot per 1.5 seconds. In other words, the right to bear arms shall be limited to weapons that fire no faster than the time an expert needs to aim each shot. Civilian weapons must be designed so they are hard to modify and boost the fire rate. The trafficking in machine-gun conversion hacks shall be considered the equivalent of trafficking in machine guns.

10/ Except during a county Senate call to arms, the possession of militia or military weapons off base, or outside a Centi-Nome armory, or while not on militia, military, or police duty shall be a felony.

11/ It shall be a capital offense to use militia or military weapons in the commission of a crime. The item at the top of this list is a machine gun.

12/ Except for police weapons, all militia weapons shall be stored in Centi-Nome armories. Militia weapons shall not leave the armory and range except for training purposes, or in a call-to-arms by the county Senate. Such a call-to-arms shall require a simple majority vote of the county Main-Senate.

13/ Government shall not restrict the right to bear loaded civilian firearms in one's home, or business, except that people with irresponsible or young dependents must lock their firearms up.

14/ Government shall not restrict the transportation of up to 6 unloaded civilian firearms per person with matching ammunition, provided both are in separate locked metal boxes. Bullets loaded in any portion of a firearm, including the ammunition clips shall be deemed loaded in the firearm for the purposes of this paragraph 14.

15/ Each county shall obey one of 10 standard rule sets for carrying civilian firearms in public. There must be more relaxed rules for carrying non-automatic, slow-fire firearms such as revolvers.

16/ As a matter of national defense, all explosives, ammunition, firearms, weapon systems, and their components, imported to our nation shall be subject to a 70% duty on their final sale value. The importation and unlicensed use of fireworks shall be prohibited.

17/ Spring-opening, and flip-opening knives being more of a defensive weapon, government shall not prohibit them

except where similar length fixed-blade and folding knives are also prohibited.

18/ Imitation and toy firearms, that look even vaguely realistic shall not be sold or possessed in this nation.

19/ Those with a firearm or a realistic simulation in hand while attempting a robbery, kidnapping, battery, or murder may be shot in the back, or anywhere else, and without warning. When bystanders shoot fire-arm in-hand criminal assailants under these conditions, it shall be considered a form of civic self-defense and the person taking action shall be considered courageous and doing their civic police duty.

20/ Where the people rise up and kill a criminal gang oppressing their community with armed force, the courts shall generally dismiss the case on grounds of community self-defense. The courts shall also be free to give new identities to those brave men who did the right thing, in spite of the risk.

21/ No weapon manufacturer shall ever be held in any way responsible, either criminally or financially for the people harmed by the legal weapons they manufacture. To do otherwise is to shut down our nation's defense industry and our nation's ability to defend itself.

22/ It shall be a felony to buy firearms for others. Straw-man gun buyers, and illegal arms merchants may be considered co-conspirators in the crimes committed by the guns they provide.

23/ All local police departments and Centi-Nome armories shall offer firearm lockers free of charge to their community.

24/ There shall be no tax of any sort on ammunition. The maximum quantity of gunpowder purchased by any person shall not exceed 3kg/year without proof of use. Ammunition shall generally not contain toxins except lead, depleted uranium, steel, brass, bronze, copper, teflon-like lubricants and gunpowder. Tumbling bullets shall be prohibited in civilian arms because of how they ricochet more and harm more bystanders. Bullets used in carry weapons may be required to bear the license number and nano markers of the carry permit holder.

The right to bear arms does not include:

- 1/ The right to bear arms in a protest.
- 2/ The right to bear arms at other people's private property without invitation. Retail stores are not considered private property with regard to gun carry.
- 3/ The right of minors, drug users and alcoholics to bear arms.
- 4/ The right of people recently under psychiatric care to bear arms.
- 5/ The right to approach people and initiate conversation while doing open carry.
- 6/ The right to bear arms while traveling to places where one is likely to meet one's political opponents.

No fear government

Democracy works better when everyone proudly saying what they think. When nobody fears speaking out. Nothing helps that state to exist like when the people are armed.

The every shot aimed rule

Consider the new rule that civilian weapons cannot fire faster than one can aim. This can be seen as a back-step from the current individual trigger pull rule where one can pull the trigger and fire unaimed shots faster than one can aim each shot. I want to make some points:

1/ Most semi-automatic firearms can only fire about 40 rounds per minute anyway, so six one way we measure and half a dozen the other way we measure.

2/ It is possible to tune semi-automatic firearms to fire faster, and to use bump stocks. However these have caused problems.

3/ This rule doesn't cause firearm defenders to lose much of an advantage while it cuts mass shooter fire rates by about.

4/ Compliance is easy to determine objectively because it isn't a matter of a list of rules, but instead it is only one measurement.

5/ It is easy to imagine that with this rule, we can have more relaxed carry rules.

6/ Perhaps most importantly, it is an absolute and perfectly reasonable line that cannot be easily effaced.

Conforming defense rifles

They all use one of two sizes .50 and a smaller size. We want as much as possible to standardize the sizes of our defense ammo. High powered size for long distances and light armor, and regular size for where there is no armor.

Defensive rifle barrel length

Assault rifles are things of charges, so the length of the barrel is as short as reasonably possible (~3-feet long). This is so the tip of the weapon can be flipped around and re-pointed quickly...like with the short swords of the Roman military. So the barrels of assault rifles are as short as practically possible. But for civil defense purpose, for sniping defenders, we want to have considerably longer barrels for accuracy at a distance. This leads us to rifles that are as long as sniper rifles a bit under 5-feet. Also, given the nature of the long shots and how people are moving around in cars, the defenders need to be able to take out people inside vehicles at great distances. So the bullets are rather high-grained and powerful. So this leads us to the strong chambers of bold action rifles, which conveniently have a slow fire rate. But the defensive rifles are long and harder to conceal.

Militaries are all offensive power

There is so little thought put into arming a people defensively, but this is the cheapest, the easiest, and the most foolproof way to stay free.

Snipers and ambushes

1/ The media heavily messes with our understanding of these tactics. There is nothing shameful about them for free men.

2/ These tactics utterly transform what it is to invade and occupy another nation. Without them, invasion is safe and easy, with them, it is the opposite.

What do you bowl?

What do you shoot?

There are 3 classes: long pistol, assault rifle, and sniper. If you hit every target, you shoot a perfect 100. If you miss 2, you have shot a 98. Some targets are close, other's not, some are perhaps moving. The sequence of targets is mixed up, but the nature of the 100 shots are not. Then we have an objective way to gauge marksmanship.

Defender training

More of being a national guardsman/ militiaman should be about marksmanship. And maybe we pay people various amounts for maintaining their marksman cert. Maybe we give them enough money to buy a reasonable quantity of practice bullets, and \$4/ hour for practicing a couple hours a season.

>>>

Also, there should be a synchronized shooter aspect to civil defense training. You get the ready 1-2-3-fire via your earphones and then you have to get your shot off within say one second.

Township armories

It is entirely possible that the police stations will be built around the armories, or in such a way that one cannot enter the armory without going through the police station.

The cowardly towns of western films

Imagine a town of 5,000 people armed with tamped cotton muskets. Imagine a 20-men showing up with state of the art and expensive 1850-era 6-multi-shot pistols and true rifles. It is important to realize that this difference in arms was what caused the lawlessness of the old West. Because everyone was afraid (rightly so) to challenge the desperados due to their better quality weapons and the cost of the good weapons.

>>>

Also, the fast gunmen of the old west... they were not fast in how quickly they took their guns out. It was more in how fast they could get rounds off with their modern riffle barrel guns.

Bolt-action single shot scoped Rifles

This is one of the best civil defense weapons around. It is very hard to invade a land armed with this sort of weapon. Yet the weapon does not facilitate armed crime so much. The guns are too big and heavy and they can only fire one shot every 7-seconds or so.

Kid-safer guns

Hard revolvers

Imagine a revolver that requires a 15-kg force to cock the hammer. So the hammer has a 3X4cm palm pad. This is so the hammer doesn't hurt when you drop the gun to your waist to bear down and cock it. So the gun's action is too heavy for small kids to cock. So the fire rate is maybe one shot per 8-seconds, and this is just fine for civil defenders hiding behind cover and using a 9" barrel 6-shot revolver. It's not such a bad weapon for civil defenders, yet it's just a little bit more effective than a knife at killing lots of people, the noise and the occasional miss being big impediments to a murderous rampage. So, to my mind, people would be safer in many places if people were allowed these as carry weapons, as opposed to no weapon at all. We might also require a hole at the hammer for inserting a padlock that prevents cocking. Police officers will have the right to verify that the action on any ostensibly hard revolver, is actually hard enough when they encounter one in circumstances where a hard revolver is required. Also, other weapons such as 2-shot derringers might be allowed the same places.

The Astra weapon

In the Mahabharata, guru Drona was a master of the Astra weapon, which seems to be a firearm.

IP and civil defense

There should be no IP protection for official national weapon systems. They must all be ubiquitized.

When is it an invading army?

Armed groups and hoards of unarmed peoples crossing into our nation may be treated as an invading army.

Civil defense rifles

I imagine these as being a standard like .30-06 with scopes and lasers. The CD guns should all be the same caliber, so people can share ammunition, and ammunition can be more easily produced.

Armor piercing civil defense bullets

For civil defense purposes, we want to have bullets with teflon and hardened steel jackets that will defeat body armor. However, because we don't want these used against police, the armor defeating bullets are only sold only in .50 calibre size, and all the civilian .50 calibre

rifles are quite long and bolt action with hand insertion of new bullets.

Guns, dogs, and marauders

I don't think people fully realize just how much stability the synergy between guns and barking dogs brought to America.

Carry yes

Machine guns no

If you're exercising your right to be armed in public, then the public can demand that every shot be aimed, and no faster weapons may be carried in public.

Civil defense is about defense, not offense. Rapid fire "assault" rifles are about offensive assaults.

Throwing knives

These are not defensive like spring open knives. They are also a clumsy weapon likely to cause collateral harm to unintended people. For these reasons, throwing knives, throwing discs and weapon darts should be prohibited.

5,000-years

This is how long it would take the US firearm homicide rate (0.003%) to equal the death rate in Eastern Europe during WW2 (15%), largely because the people were not armed.

So yes, disarming the people will save lives, until there is another great war. And if that happens in less than 5,000-years, we are better off with the guns.

Second hand smoke and gun control

5.5X as many people die from second hand smoke as firearm homicides. 72,000 die in the US from second hand smoke and 13,000 die from fire arm homicides.

<Guns and fatalities graph>

There are a number of graphs and there appears little relationship between gun ownership and homicide rate?

Concealed carry

1/ The training courses and the rules for firearm use shall be uniform for concealed carry permit holders nationwide.

2/ There should be say 8 categories of concealed carry: Agent, national police, local police, civilian-deputy active duty, civilian deputy passive, civilian, and civilian emergency guard militia. Each should have different national rules.

4/ Agents, police, and deputies will be allowed to carry nationwide mostly.

3/ Certain counties will allow civilian carry, others will not.

Public carry rules

1/ All public carry must use silver bullets.

2/ All shots must be aimed, no rapid fire guns.

3/ People from other counties may not carry weapons unless they are police or a deputy.

4/ Age guidelines: No girls under age 20, or boys under age 25 may carry. Girls between 20 and 25 may only carry weapons that are .32cal or smaller, and medium grain or smaller. Those over age 63 who wish to carry must pass an annual DMV dementia test.

5/ Everyone who is carrying in public must have a no-carry alert app on their phone. This is to keep guns out of the no-gun zones a county governments needs to establish.

Implied consent for open carry

When cops encounter a carry weapon, they are free to take a ballistics sample if they have a bullet catcher.

Firearm registration and ballistics

1/ Those trafficking in illegal or untraceable firearms get life at hard labor.

2/ Those who are in possession of firearms modified so they no longer match their ballistics records get 20-years.

3. The serial number is on left, right and top of the barrel in #14 bold font stamped into the metal.

Serialized bullets

Maybe everyone carrying a loaded firearm in public should be required to use ammo with nanomarkers in the powder and serial numbers in the bullet cores. These might also be silver bullets that don't have lead toxicity. There is no need for lead toxicity in civil defense bullets, is there? These are bullets that are stamped with a registration number tied to a person.

Variable carry penalties

There are too many people in US jails on weapons violations. Maybe variable penalties will help. There are certain people we absolutely don't want carrying guns ever. And there are other people where it is really not that bad, especially if they are in a crime infested neighborhood.

1/ If the person carrying the gun is a former felon, the penalty is 20 years. Drug possession and distribution offenses will not count here as felonies.

2/ Young people under age 25 that are caught with a civilian firearms go away to work camp / school for 4-years. They get half their wages in a slow-flow account upon release.

3/ If the person with the gun is over age 25, a high school graduate with no criminal convictions, and they have at least 4-month's average pay in liquid assets at the time of the arrest, and they are carrying a firearm registered to them, the penalty should not generally exceed 400 hours of community service or education, and this should generally be a misdemeanor offense.

Firearm violations

It is one thing when people with jobs and no criminal records are in possession of firearms, and it's a completely different thing when people have criminal records and they are carrying guns around the city. The punishment should be different. One is an infraction and the other is a serious crime.

Flame throwers

They are much more like machine guns and bombs than they are like muskets, or hand guns. They should be considered like machine guns.

Chicago gun laws

1/ Each nome of 250 in certain parts of Chicago might have 5 to 20 deputies (2% to 8%) that are supposed to be in arms. These are only supposed to intervene if firearms come out.

Barney Fife

This idiot deputy character was someone messing with our heads politically. They did not want us thinking of armed deputies as effective or smart. In truth, deputies seem a great way to reduce gun crime. This especially in lawless places like parts of Chicago.

Civilian carry deputies

Society can have a ready auxiliary and backup police force if it wants for nothing more than the cost of screening and gun carry certification as payment. If you want to carry, you have to agree to be a sort of backup deputy if you are armed and you are in that place. Also, maybe:

1/ Deputies have to agree to have their general location available to the recorder and the police while they are armed and in public.

2/ Deputies must have served without problem in the Police, Military, or other high confrontation work for a number of years, or be over age 40.

3/ Deputies must be better screened and better trained in regard to marksmanship and de-escalation than normal carry holders.

Gun cams

1/ They have multiple cameras, including a backwards-facing camera.

2/ They have a charger in their safe/rack.

3/ They come on when lifted or tilted horizontal.

Gun cams

1/ Our phones come-on when we lift them. Gun cams should also come-on when the gun is moved or lifted. Then the gun cam calls the county recorder which provides free backup for gun cams that are signed up to the system. This includes police.

2/ Some jurisdictions will allow cam carry where before they did not allow carry at all. Other jurisdictions will

change their carry rules to require that all carry weapons have a cam.

3/ The cam itself backs up video like a dash cam.

4/ It is impossible to delete files, only to destroy the camera and gun and cover the main lens (The main lens is inside the forward sight block.)

5/ There should also be a presumption of guilt if a gun cam is used but there are no files due to any cause such as: dead battery, cam off, or cam broken, etc.

6/ Central command and arriving officers can patch into the recorder's gun cam feed.

7/ Gun violence civilian defense deputies can call and ask for guidance.

8/ There is a delay for turning off the cam.

9/ Some gun cams will permit the admin to turn the gun off if it is being used by another wrong person.

Maybe the admin can turn the firing off if kids are playing with the guns.

10/ Maybe there are 2 or 4 cameras recording at once.

All police cars have 3 firearms

Side pistol, scoped long rifle for the trunk, and a shotgun with 4-types of round:

1/ First round up is a "gentle" rock salt round

2/ Second round up is a "strong" rock salt round.

3/ Third round is bird shot with an irritant.

4/ Fourth and subsequent rounds are maximum carnage rounds. If the cops don't want the first rounds, they cock the cartridges out. Also the rock salt rounds are supposed to be aimed for the legs. This is how police deal with people armed with a knife or a quasi-weapon. Also, all rounds are color coded and all police shotguns are kept chambered exactly the same nationwide so people are not getting shot with the wrong type of round.

.22cal less lethal sniper rounds

In the original Terminator film, there was this scene where the terminator was pulling bullets out that got stuck in its flesh coating. So here we imagine a bullet that breaks the skin and goes in, but only barely. This is a weapon for giving people nasty looking wounds that will tend to be much less deadly than a larger and higher energy bullet. Maybe it is 22cal or .15cal hollow point, low grain rounds. Here is a police weapon stronger than rubber bullet but far from a killer round. Also, these rounds might have a burning irritant on them.

Hollow point bullets

We want the police to be able to use lowish-grain medium-calibre extreme-spread hollow-point bullets, because these are less deadly for others behind walls. If officers are confronted with body armor, they can grab a high grain Teflon clip from their belt.

The taser rule

If the Tazer doesn't work, you better lie down anyway, because about half of the time, they are going to shoot you. And it's going to be your fault.

Fast firing pistols and police

Faster firing pistols might not be considered militia weapons if used by police officers.

Who can be shot without warning

- 1/ Strangers in your home at night.
- 2/ People who break-in to an enclosed premises during a riot or uprising, or during a natural disaster.
- 3/ People who are holding arms on others while committing an armed crime such as robbery or kidnapping. The person taking action must however be reasonably certain of the situation and may perhaps bear full responsibility if they are wrong or miss.

Limitations on the right to shoot home intruders

The right to shoot home intruders merely for their presence in a residence is a thing for sane people and strangers, not for substance abusers, or people that are acquainted with each other. This right of home defense may be easily voided when:

- 1/ The resident is licensed for crystal meth, or heroin, or to licensed to drink over 5-drinks per day, and for other drug licenses in various measures.
- 2/ The resident is not allowed to possess a firearm, or has been institutionalized for mental illness.
- 3/ The resident and the intruder have/had an ongoing history and there is no government restraining order.
- 4/ The resident is acquainted with the intruder, and the resident's blood alcohol was over 0.1%.
- 5/ There has been a party in the past 24 hours at the residence.
- 6/ Those who wear masks or hoods inside another person's residence shall generally be presumed to be strangers even if they were not.

Family firearms

Registrations by spouses, parents, grandparents, children, grandchildren, and genetic full or half siblings are normally considered registered unless the arm was reported stolen.

Theft of firearms

Theft of individual firearms is considered both theft and possession of an unregistered firearm, so the penalties are around 30-years. Theft of many firearms should be considered akin to terrorism, and those caught in possession of large numbers of stolen firearms are subject to life at hard labor.

Traveling and weapons

We should be biased in favor of local defenders and against travelers with arms. I do not support arms or even weapons for people who are traveling, unless they are in a war zone. There should be a UM map & app to remove any confusion.

Closed districts

It isn't hard to imagine some lawless Brazil favelas implementing closed districts. This is when the districts puts in walls and checkpoints that verify everyone's ID and arms carry upon entry. Do we have a global standard for this sort of thing based on the homicide rate? Will this cause people to get killed to create and keep closed safety districts? Maybe we should study how this goes and when districts can be closed, and what size is optimal.

Civilian weapons shall be tax free

- 1/ Government shall have no tax, fee, or charge on firearm registration, or carry licensing, or domestically made weapons and or ammunition. Foreign made weapons and ammunition shall have protective tariffs.
- 2/ Those buying a firearm shall not be required to complete any education.
- 3/ Government shall prepare media about things like bystanders, bullets going through walls, firearm kick, and basic rules of carry and firearm maintenance.
- 4/ The classroom education required for a carry permit shall not exceed 8 hours. The firing range time shall not exceed 2 hours.

.50 calibre rifles

These keep the people safe from those who wear body armor. These are important weapons

National ballistics registry

Given the patriot act, and the state of information tech, we are kidding ourselves that this does not already exist.

Safety box cutters

- 1/ Safety box cutters have smaller, short blades will cause less harm to products. We will have #3, #4, #5 & #6 cutters for the various thicknesses (3mm to 6mm) of corrugated cardboard. Safety box cutters have a flat edge that must be longer than 7cm. This long flat edge is an important aspect of making this sort of cutter an ineffective weapon.
- 2/ Safety cutters are seldom considered weapons when carried on a person, except in schools, airports, and parties. On the other hand the sort of box cutter where the blade can be projected over 2.5-cm shall always be considered weapon-grade knives if carried around the person.

Weapons and parties

When people bring weapons to bars or drinking parties, or drug parties, they are generally subject to double or triple penalties for weapons possession and brandishing.

Boys, knives & box cutters

Minors under age 18 should not have or carry around knives, folding knives, or box cutters except for verifiable work or wilderness needs, provided these are kept in a box or bag while not at work or in the wilderness. Wilderness areas within cities do not count. Safety cutters do not count.

Which firearms must be registered?

The carry and work arms must be registered. The home and properly boxed range firearms might not have to be registered. Also the firearm registry is not public information and it is only for police use, and then the system only matches ballistics to a number which is matched on a different system to a person. Maybe government should not be certain who has arms and who does not.

Black market firearms in America

If there is one place we want to have sting operations it is in selling black market guns. This is the #1 most important place for sting operations.

Protest

“Crushed bodies and shattered bones”

—Xi Jin Ping, threatening a second Tiananmen massacre.

The number is 10,000

Just google "Tiananmen + 10,000". The BBC Reported 10,000 at the time in 1989.

R'184 Non-violent protest

1/ When the people gather in great mostly peaceful numbers as they proudly did in Hong Kong, Barcelona, and Tiananmen, it shall be thought a glorious and sacred thing that is straight up to us. Those who menace and threaten peaceful protesters shall be seen by all as tyrants and the enemies of freedom.

2/ We shall immortalize the words of Xi Jin Ping and the Chinese Communist Party: “Crushed bodies and shattered bones”. These words were said to the democracy protesters of Hong Kong when China threatened another Tiananmen massacre. This direction is straight down to us in the land of the free.

3/ Protesters shall not wear a uniform or same color clothing as this supports protest crime. Protesters shall not wear face coverings, even for reasons of religion or infectious disease.

4/ When large numbers of protesters approach people in a menacing way, or they threaten with words, even vague

words, the crowd itself may be seen as a weapon, and the people in the crowd may be charged with armed assault.

5/ The right of protest shall never be allowed to become a thing that may be directed at individuals or small groups.

For when this happens, we have started down the road towards the Jacobins and the French Guillotine purges that killed some 30,000 royals and genuine leaders.

6/ The right of our leaders to be safe from threat of violence is obviously a first-order protection for our democracy. Without this, it is a step towards SA empowerment. (The SA or Sturmabteilung was the thug army that brought Hitler to power by silencing his opposition.) Therefore, the right of protest shall not include the right to menace people for what they say and do.

There shall be no right for protesters to go to people's homes, even as individuals, or for protesters to menace or confront individuals and groups in the street, or during their meals or errands. And this protection shall expressly apply to all leaders, lawmakers, political figures, authors, critics, commentators, media producers, talking heads, judicial people, police, and those accused, but not convicted of a crime.

7/ False anarchy always presents itself as a disorganized mob. Where this mob is used to overpower or influence elected people and true leaders — this is one of the most vulnerable points in a democracy. For this has ended many democracies. Therefore, we will have a powerful new rule for mobs (including lynch mobs) that go to people's homes and threaten extra-judicial violence.

These home visiting mobs shall generally be considered by the law as having firearms in hand. Under the law, everything they say and do shall be considered as if they all had guns in hand. Thus the mob may be dealt-with by the defenders as if they were holding firearms in hand.

8/ Burning things at a person's home for reasons of politics or racial suppression shall be considered just the same as firing a firearm into their home. The defenders may return fire and may treat those running away as retreaters that will return.

9/ When a protest is peaceful, the burden of proof lies with police, and penalties shall lean towards the minimum. When a protest is deemed violent, or a riot, the burden of proof lies with the violent protesters as much as reasonably possible, and the penalties shall lean towards the maximum.

10/ Protest should never be an excuse for violence. The right to protest is the right to protest without violence. Non-violent protest is perfectly fine for democracy. Violent protest is bad for democracy.

11/ No sign posts are allowed at protests. All signs must be on non-weapon sheet material such as cardboard or foam plastic with no sharp edges. No plywood, metal or timber backed signs are allowed at protests.

12/ There is no place at protests for any weapons or even potential weapon. Prohibited protester weapons include:

firearms, bullets, firearm replicas, paintball guns, squirt guns, toy guns, bombs, firecrackers, fireworks, flares, lighters, matches, accelerants, pepper spray and other irritant sprays, electric shock devices, knives, folding knives, razors, axes, chains, scissors, pry bars, screwdrivers, pliers, rocks, bricks, canned food, sticks, picket poles, clubs, bats, hammers, saws, wrenches, metal spikes, nails, screws, glass bottles, broken glass, helmets, face shields, hoplite shields, body armor, bullet-proof vests, knee or elbow pads, heavy or hard-edged footwear, skateboards, bicycles, motorbikes, gloves, wire, rope, drones, quick-ties, hand cuffs, slingshots, ball bearings, marbles, cleaning fluids, body fluids, noxious fluids, sprays and gasses. At protests, the definition of what constitutes a weapon shall be much broader and more inclusive than normal. People may bring their wallet, keys, communicator, medications, soft plastic water bottles, soft food, and not much else.

13/ There shall be no bags, backpacks, suitcases or other means of concealing weapons at protests.

14/ There shall be no open fires at all at protest, including flag burning, effigies, and street bonfires. Starting, tending, or spreading a fire at a protest shall be considered as arson. Those carrying incendiary devices or burning objects at protests shall be presumed to be arsonists. The penalty for possession of fire accelerants at a protest shall be 30-years. The penalty for possession of a lighter, matches, or other fire-starters on one's person at a violent protest shall be up to 5-years.

15/ Those distributing weapons at protests, to include rocks and bricks, get 20-years. Those recorded or witnessed at protests with rocks, or similar throwing objects in hand, or in their possession get 2-years of work camp. Those recorded or witnessed at protests causing breakage damage get 5-years in work camp.

16/ Nothing weakens a protest like vandalism and destruction. So when part of a protest turns to looting, violence, or arson, the peaceful part has an obligation to flee (both physically and in unequivocal words) from the violent part. This is so the violent part may be more easily separated and punished. When peaceful protesters fail to separate immediately they may be held to be supporters and shielders of the violent protesters.

17/ Committing crimes in the name of protest is the opposite of justification. Those who commit crimes at a protest shall generally suffer double penalties for property crime and altercations without serious injury. They shall generally suffer triple penalties for violent crime to include arson, attempted arson, and weapons possession.

18/ When a mob runs riot through a city committing widespread vandalism and destruction, all who ran with them shall be charged as co-conspirators.

19/ During times of protest, entering a business or home that is obviously being looted shall be enough to make a person a looter. The only except is when people are live streaming faces to police or the recorder.

20/ Those convicted of throwing water balloons, or using a squirt gun, or making menacing gestures, or throwing food or following people trying to get away from the protest, or similar micro-assaults at a protest may have to do up to 1,000 hours of community service per count.

21/ If recent protests have been violent, then government may require that all protestors pass through a metal detector. However government may not delay people more than 10-minutes for this.

22/ There shall be no night time protest from 20-minutes after sunset until sunrise. People can camp-out, but the marching through the streets and public speaking, one person to the crowd, that must stop 20 minutes after sunset.

23/ The right to assemble is the right to assemble openly, and unmasked. All who protest do so openly and they shall have no right to privacy. They may be freely recorded and their images freely promulgated without consent or compensation. The penalty for wearing a mask, including a gas mask, at a protest shall be 40-days in jail + a fine of 3 month's pay. If the person has no money, then the penalty shall be 2-years in work camp.

24/ There shall be special protections for individuals and small groups when their legitimate protest and participation in the public discourse brings even extra-judicial threat and menace. Memetic diversity must be preserved in the group mind, and small groups are especially vulnerable to extra-democratic coercion and menace from aggrieved parties.

25/ So long as all violent protesters are stigmatized by the mass of people, the protest shall be deemed peaceful.

26/ Government shall be free to use video-drones, listening devices, and data traffic interception at protests.

27/ Giving away bottled water, beverages, and food shall be considered as paying for protest.

28/ There shall be a crime called "accessory to protest looting". This is the crime of people who don't loot, but don't run off either.

29/ There shall be a crime called "accessory to protest arson". This is the crime of people who don't burn things, but don't flee from protest fires either. Those recorded near a "bonfire" during a protest may be charged with accessory to protest arson.

30/ All non-humans, and non-voters must keep-out of the nation's protests to the maximum extent reasonably practical. This includes kids and elders. This also includes government and its police where reasonably practical. This also includes all fictional citizens, all visitors, all non-voting citizens, and all foreign governments and their people.

31/ Private drones and robots may only be used near a protest with prior approval by the police.

32/ Using fireworks and firecrackers at a political protests will get a person 5-years at a work camp.

33/ When people with long criminal records are charged with protest violence, or disaster looting, or disaster violent crime, they may be sent to a work island for life.

(Looting here does not include provisioning a reasonable amount of essentials).

34/ Nobody should ever be penalized for participating in a peaceful protest. This should be a worldwide rule. Any government breaking this rule becomes illegitimate. Any strictness comes from the definition of peaceful.

35/ Small protests of fewer than 50 people may go just about anywhere unless they are intentionally blocking some function.

36/ Only the national government may establish rules for free speech and assembly and all places open to the public shall obey the same access rules nationwide for those wishing to protest or spread information. Private property owners who violate a person's first and foremost right of free speech and their right to reasonable political assembly or protest should pay toxic waste level fines. When police do this, they should be fired. When private security guards should do this, they should go to jail for a year. This rule R'184.36 only applies to political matters and it does not apply to matters of commerce or religion.

37/ Tear gas shall not be used on peaceful protesters, and police are expected to warn that they are going to use tear gas.

Insurance for civil unrest

1/ This type of insurance should not be valid unless the business has steel roll-down doors that were locked over all glass panels, like the stores do in many parts of Italy.

2/ It doesn't apply to store electronics, jewelry, luxury products.

3/ It doesn't apply to businesses with more than say 60 outlets. These should self insure.

Gauge Halupowski

This man attacked a stranger from behind at a political protest. Because he hit the victim in the head twice with one of those telescoping metal rods, he should have been

charged with attempted murder. He also assaulted the arresting officer. As all of this was at a protest, he should have been given a multiplier penalty. Thus he probably should have gotten something like 15-years for the attempted murder plus 5-years for the assault on the officer assuming it was mild. And the penalty should be doubled or tripled considering that it was at a protest, so he should have gotten 40 to 60-years. Essentially he gets a life sentence to show what happens to violent protestors in our democracy.

It is very important to the proper functioning of our system that no group can jam or hinder the right of protest by making it dangerous. Anyone doing so (like Antifa) should be considered as a sort of democide.

Paid protesting

Transacting in the services of paid protest shall be considered equal to vote buying. Providing or subsidizing transportation, meals, water, or lodging to other people attending a protest shall be considered payment and treated just like vote buying. Calling-in favors, or promising them shall also be considered payment.

Free speech at colleges

1/ Schools for grown-ups over age 18 may not interfere with free speech unless it either results in harm to the facilities or it threatens harm to people.

2/ All colleges shall not limit free speech any more or less than the other parts of society.

How do you get a smart democracy?

In order to vote, one has to pass high school or the equivalency test in the national language. This is not too much to ask for a test of suffrage in an informed democracy.

2/ People are said to "have it made" or "got it made", a reference to their Senate resort system access.

4.5 million Doctorates

500,000 Sub-Senators annually

100,000 Main-Senators annually

10,000 Over-Senators annually.

1/ Being a confirmed Sub-Senator will not quite be as rare as being a Ph.D. But being a Main-Senator will be much rarer.

And being an Over-Senator will be even rarer.

2/ The cred these people have is not a thing to be used on an individual basis. They are like individual jurors, and they hold no official power over others as individuals. The only power they have is as groups of appropriate size.

Who is the Senate's constituency?

The Senate shall favor groups that will exist and contribute to freedom in future generations in our land over those groups who will mostly die out or not contribute in future generations. The groups that the Senate may dis-favor include: homosexuals, onanists, leavers/expats, convicts, secondary school flunkies, illiterates, and the mentally incompetent.

Public hearings

1/ There is much less need for hearings in a broad democracy because there are better connections between the people and their representatives.

2/ The purpose of the hearings is not to sway government but to get more ideas.

3/ The hearings must as much as reasonably possible be run by randomly drawn and disinterested Sub-Senators.

These must be from another non-contiguous county for all county matters. They are also not supposed to hold strong views on anything being discussed at the hearing.

3/ The same Sub-Senators also curate the stream and prioritize the comments for input value. The hearing stream can either be played in full, or it can be viewed by best first.

4/ Everyone meets virtually via a twitter-like system.

Executive privilege for leader

We must protect our leaders and prophets from those they harm with their words and new approaches. So for this reason all great leaders and especially prophets shall be generally immune from most prosecutions and all money court actions unless and until the Over-Senate of their nation decides to take action against them, even if they are in another nation.

Senate posting rules

1/ Nobody else shall be allowed to tweet or communicate on behalf of any active Senator.

2/ All Senators must post to the senate board first.

What do we get in return for letting lawmaker swayers know if their corruption efforts actually worked?

No double jeopardy for leaders

You can't have this sort of a circus like the Blues in the house of representatives repeatedly attacking the Red president.

Senators are not supposed to discuss their voting & people are not supposed to ask.

The main senators are not done

They are all still trying to make it into the OS. So the main law making body is not the end. Instead, everyone is still trying hard.

Presidents

1/ We should not have leaders unless that person clearly stands above the rest in terms of vision. If no man stands above the rest, it is better to be a headless democracy.

2/ The powers of a president are only advisory, and the legislature may listen or not. So the governing power of a president is only really the power to address the Senate and the people and to be listened to. In other words, presidents should have no official power, except perhaps in breaking at tied vote.

Court rulings in the Senate

In general, court rulings should not hold much validity in the Senate. Otherwise the courts become a back door to Senate power.

Voting

John Lewis

"I don't necessarily think that democracy is about electing representatives. I think it is more about finding a body of smart and honest leaders that cannot be easily corrupted."

The 1% rule

If there is no clear winner by 1% the election must be redone.

Voting age

- 1/ Everyone over 18 with children at home should be allowed to vote.
- 2/ The most academically progressive 20% of 18 year old should be allowed to vote
- 3/ The most academically progressive 20% of 21-year olds not on the other list already should be allowed to vote.
- 4/ Everyone over age 25 should be allowed to vote.

Cross town nomes

People should be able to join cross town nomes if they are running for office. It is just a lot easier if you live in the neighborhood. Unless you are clearly Senate "material", in which case you might move and try.

Low voter nomes tweak to BD

Let's consider the way New York's 14th congressional district has 706,000 voters and only 152,000 participated in the 2020 election, with only 105,000 voting for Al Cortez. (a 21.5% voter turn out, and 15% to elect). Clearly democracy breaks down in communities of such apathetic and indifferent voters, and such low voter turn-out.

>>>>

We should have a rule that the community cannot be apathetic, and must participate in the democracy to a certain extent, or it cannot elect Senators. We should probably say that "inert nomes" that do not have a "polling quorum" of least 1/4 of the eligible voters watching the candidate presentations do not get to elect Senators. And maybe this should even be boosted to 1/3, or 1/2.

>>>

This might drive a separation of the nation into voting and non-voting communities, with the latter being regarded sort of dregs. This also drives the people in the middle to get involved. Because they don't want to live in a dregs community.

Voting age

After going to the the BLM protests and talking to hundreds of young people, I have changed my mind about voting age. I now think that most people are still rather dumb at age 18 and even age 22, at least as far as politics and economics go. They are also quite vulnerable

to ideological manipulation. So let's err on the other side and put the minimum voting age at 25, except where the citizen is over age 18 and is either in the most progressive 20% of students, or they took the Senate's 80-hour video primer on money and government. voting course. Note: The primer must be completed within 80-days. The viewers also have to answer a few listening questions correctly per hour. This will be a very popular high school subject. Those who are currently 18-32 years old who want to continue voting must complete it in order to vote.

Eligibility to vote reminders

Each county recorder shall send each resident 3 emails prior to each regular election. One email is 60-days prior, one 10 days prior, and one the day before. This contains the person's name and whether they are OK to vote as far as the county is concerned. The 60-day notice is mostly to clear up registration problems. The 10 day is mostly a reminder to get informed. And the day before is a reminder that tomorrow is voting day. These go out to everyone's must check email address discussed elsewhere.

Video voting by line

Everyone who is voting walks up to the camera with their votes printed on a 8x11 sheet. This includes the voter's name. 10 people come together and stand on a line facing a row of community people who are taking videos. There is a clock in the middle of the line. Then the people get motioned away. Then a new group comes of 10 people comes up to the line. There are 100 lines of 10, or 1,000 voters per folder, People are told their folder and line number. Later the video is screen-shotted and each voter's clip is posted for all to see.

Voting check-in

In order to cast a vote, people must provide their social security number, their thumbprint, and have their photo taken with their vote on it. They all must also be citizens. CBP officers and police handle the ID verification. They also check for felons and people with arrest warrants. This will scare away all the people who don't know if they are wanted or not — no small number of corrupt derelicts that should not be voting anyway. There are signs in many languages about illegal voting and how it carries a penalty of 10 years in prison per count.

Crier vote counting

Maybe instead of a long line of people counting votes we have criers that run a ballot through a counting machine where the result displays on a screen and the printed on the ballot. Then the ballots are handed by someone else to the varied people in the surrounding crowd for verification.

Nomes and electoral co-lodge voting

This is where each Nome is counted as one vote depending on how its people voted. Under this system, voting openly is always safe because there is no benefit of total conformity in extremist neighborhoods. It will not make any difference if everyone votes left in that poor neighborhood because the nomes will all go left anyway. And they same with neighborhoods on the right. And the neighborhoods in the middle will have too many people on both sides.

M signs for mustering

The sign for a mustering nome is the capital letter M the size of a yard sign. The color is bright red. Then under the M people write the names and days for mustering. Cardboard and spray paint M's with arrows may be used.

The voter participation ratio is in a saddle

Both extremes are bad

If less than 20% of people are voting, due to say a property ownership requirement, then most people are disenfranchised. So we don't want too few people voting. On the other hand, we don't want too many voting. We don't want felons, non-citizens, illiterates, and the mentally compromised voting. So the best suffrage ratio is high, but not where everyone voting because we don't want felons, non-citizens, illiterates, and the mentally compromised voting.

National Lawmaker vote audit

Let's hold a new census and among the other questions, we will ask people if they voted and how they voted in the old 1789-era democracy. Then the law makers that won through fraud will be obvious.

All paper ballot voters must

- 1/ Check-in and verify identity, address, and citizenship on video.
- 2/ Give a photograph and a thumb print.
- 3/ Thumb print their ballot upon receipt if paper ballots are used.
- 4/ Use the voting book by themselves without any recording of their ballot. It is the crime of 2nd degree vote selling to take a likeness of your ballot that might be shown to someone paying you money.
- 5/ Write the names of the candidates they are voting for in their own hand.
- 6/ Put their thumbprint on the outside of the ballot.
- 7/ Put the ballot on the scale.

Nomes and ownership recording

One of the very first things that our new Sub-Senate Centi-Nomes will do is record ownership of property due to the reapportionment. They will prioritize their response based in length of occupancy, shortest occupancies coming first. Also claims of squatting,

usurpation, and especially violence and intimidation go to the front of the line.

Centi-Nome armories

These have things like bio-protective garments... water purification... medical supplies... disaster equipment, Earthquake jacks...disaster drugs, etc. These disaster items are in kits on pallets that can be easily trucked off to where they are needed. They are of a particular design and style worldwide and these things are all commerce forbidden. Nobody can buy or sell or use the distinctive dated emergency stuff from an armory except in an emergency. also, there is no central storage. All the emergency supplies are at the nation's ~5,000 Centi-Nomes.

Going to a poor nation to run for Senate

When learned foreigners come to your land, you should compare them accurately to your own people. Be a sliver biased in favor of them until they are at least 5% of your senators. Then be completely unbiased. Also, when people go to a poor place to run, it should be seen as similar to joining the Peace Corps. This going to poorer parts of the world should never be seen in any way as cheating, or less than Senate service at home.

God mind

Our democracy failed in this respect. No absolutely clear ring of truth here for the entire world to follow.

The college of software Ubiqs

This is all the Ubiqs over a certain point level. These guys have an advisory role for the Senate in all matters of programming. And certainly we will have similar colleges for immunology, for bridge engineering, for cymology, etc. It is important that the people making the good changes in their area are given some cred in directing their area in the future.

Emotions don't make one human

The post-theist god's fuel

The respect, friendship and kids that people give to their Senators and Ubiqs will be the fuel that makes people struggle to innovate and to become Senators. And it will be very important to prevent the counterfeiting of this status, so it may become the coin of the realm of politics and group contributions.

Why my message is long

- 1) It prevents people of limited abilities from commenting on it.

2/ What a great and useful game this will be for many.

3/ What a great source of well-deserved pride and status this will be for many.

4/ How much smarter our group mind will be for this.

5/ What a great way to motivate people to keep the whole in mind.

6/ What a great way to accurately identify our true leaders.

Ubiq rating system

The smallest increment of Ubiq status is 0.01. Until you are given 1.00 Ubiq points by the Sub-Senate, you are not an Ubiq. After earning 1.00 Ubiq points, you are an Ubiq for life and all your genetic offspring are considered sires.

UBIQOLOGY = the study of democratic status, especially its administration, its results, its fairness, and its optimization.

Public status

All public status awards must pay the recipient some money, even just one week of wages. Also, the ubiquitization budget is supposed to be a thing with countless tiny rewards, and some big notable ones too.

Criminal Code

Violence-1 = Gun/knife Battery. This includes battery by gunfire, or stabbing by large knife to the torso, neck, or head or groin. It also can include striking someone's head forcefully with a potentially deadly weapon to include bottles, rocks, clubs, and surfaces. V-1 is just below attempted murder. Severe or repeated stabbing, slashing, or beating can be considered attempted murder.

Violence-2 = Club Battery. This includes small knives, and smaller stabs and slashes. . blunt impact weapons, and any attack on the neck/throat, and repeated hand or foot beating of the head, neck, torso, or groin. It also includes rock and sand throwing: with significant injury. Shoving or striking a person's head hits a surface with significant injury.

Violence-3 = Unarmed Battery. This is fist and hand fighting, except for targeting the throat, eyes, or groin, or when it drives the head to strike the ground or a wall. It includes spitting in the face, improper use of sprayed irritants with no long-term harm, and may include intentionally burning people with one's cigarette. It is participating in a protest that goes to someone's home, or a makes demands on people the protest encounters under implied threat. In both of the last two cases, the protest is becomes the weapon that threatens violence.

Violence-4 = Slapping Battery. This is a women slapping a men's face hard. It is punching someone on the shoulder, or kicking them in the legs. It is scratching hard with one's long fingernails. It is spitting on the body, It's throwing soft things like food, water.

Violence-5 = Virtual Battery. It is getting close to someone and screaming, or cursing at them, or intentionally insulting someone. This may not be a crime in many jurisdictions and circumstances. And in some it will only be a crime if the victim is before an audience, or broadcasting live, or protesting, or voting, or or a leader of men, or a Senator, or police officer. Virtual battery might also include the haring of personal information as a way of doing harm to a person. if it is done with intent to cause harm to someone.

Sucker punches

These should get 2x-3x the penalty.

Attempted murder

1/ It should be a capital offense under some circumstances.

2/ Attacks by flammable, or caustic fluid should generally be considered attempted murder, even when the amounts are small.

2/ Attempting or plotting to kill a large number of people as an act of terrorism, should be considered attempted mass murder.

Murder and the death penalty

1/ Not only do I believe in the death penalty from certain crimes, I also believe in torturous punishment for some.

2/ One trial is necessary for government to kill a person if the evidence is irrefutable. Two de novo trials should be necessary if the evidence is not irrefutable, and both must convict.

3/ Once someone is sentenced to death for murder, they may only be exonerated or pardoned. There should not be parole or probation for those serving a life sentence, or on death row awaiting death for murder.

4/ Everyone serving a life sentence or a sentence that began as more than 40-years shall automatically be considered KTPR = kill to prevent release in case of invasion or natural disaster.

5/ Those who attack others with burning fluids such as acids or ignited accelerants causing severe bodily damage, and those who have killed as hired killers shall be added to the list of conditions eligible for torturous death sentences.

Sex trafficking

1/ Those having sex with un-registered prostitutes may be charged with trafficking. Those having sex with registered prostitutes may never be charged.

2/ Being found in possession of the travel documents of multiple unrelated women should be enough to convict for sex trafficking.

3/ What did they sell in cells? Those who keep people locked in cells or complexes can be judged as slavers and sent away for life.

4/ Pimps and those brokering and having sex under threat, or lockup, these people risk being sent away for life with the sex criminals. The message should be clear that people stay far away from sex trafficking and anything but licensed prostitutes that have regular visits from police to make sure they are not being exploited by third parties.

Child porn

1/ Material containing 16-19-year olds, should get 1x punishment.

2/ Material containing 14-16-year olds should get 3x punishment

3/ Material containing 12-14-year olds should get 10x punishment

4/ Material containing pre-puberty subjects should get 30x punishment.

5/ Those who make and distribute child porn should suffer 8x to 16x the penalties of those who possess it depending on the scale of the distribution.

6/ If the material depicts children having sex, the penalty is 5x that of nudes.

7/ If it is just a few images of a sub 6-year old family member playing naked in the sprinklers, or in the background, it should be ignored by the law. But it might not be. People are supposed to delete these images and not to forward them.

8/ Thus, the people in possession a porn collection containing 16-year olds might only suffer some weeks of community service and misdemeanor charges. On the other hand the makers and distributors of porn depicting numerous pre-puberty children having sex might be removed from society forever.

Types of murder

1/ Planned murder = murder-1

2/ Unplanned murder with malice = murder-2

3/ Passion homicide = voluntary manslaughter.

4/ Negligent homicide

5/ Honor murder is always considered murder-1.

Jail and execution for murder

1/ If someone plans and kills two or more people, and there is no doubt in at least two cases, they shall be executed.

2/ If someone intentionally kills one person, and there is no doubt, they can be executed with a 75% over-majority of jurors. This might apply if the victim was a police officer, or child, or harmless person.

3/ For unplanned murder with malice, they get life at hard labor.

4/ For passion homicide, they get up to three decades, which can be reduced depending on the circumstances.

5/ For gross negligent homicide, they get up to 10 years.

6/ For honor killing, they shall be executed if they fail to become apostates to their religion. If they become apostates, they shall serve life in prison.

Firearm brandishing

[This is any threatening reference to a firearm that one is carrying that is not in self defense.](#)

Brandishing-1 = taking a gun out & not pointing it.

Brandishing-2 = lifting one's clothing to reveal a firearm as a means of threat, or putting one's hand on one's holstered firearm, or gesturing towards one's hidden firearm bulge. It also includes verbal reference to one's firearm.

Pointing a weapon

In order to encourage the use of longer barrel, more accurate defender arms, the definition of pointing a weapon shall be more precise:

handguns barrels under 15cm = 45° minimum

handguns barrels over 15cm = 30° minimum

Rifle barrels over than 50cm= 15° minimum

Shoving people

- 1/ The way that Martin Gugino was shoved should be considered as if the officer had blindly swung a club and him in the head.
- 2/ If there is no injury, a shove like this should be considered a missed punch to the face.
- 3/ Riot police can only shove people like this if they have taken one step back in the past 10 seconds due to that person, or three steps back due to that person in the past day.

Perjury refined

- 1/ All crimes of criminal procedure must be tried in a new and separate trial immediately after the first trial. However, this trial shall not exceed 4 hours in length and the burden of proof shall rest with the prosecution to prove guilt.
- 2/ Perjury convictions require all of the following:
 - a / The thing lied about must be an important decision point in a trial and there must be significant benefit for the accused in lying. This includes helping friends and family to avoid conviction.
 - d/ The thing lied about must be an absolute and cannot resemble a relative thing that might change depending on when it is described.
 - c/ There must be criminal intent to lie or mislead without correction during the trial.
 - d/ Perjury is a crime of the courts and affidavits and not of interactions with police.
 - e/ The evidence of the lie must be incontrovertible.
 - f/ Equivocal statements must be interpreted as broadly as reasonably possible.
- 3/ Nobody should every face penalties for maintaining their innocence. And statements about one's innocence shall never be considered grounds for a perjury conviction.

Trespassing refined

All of the following types of trespassing need different penalty ranges, and realistic penalties that match the crime.

Trespassing on a private balcony or patio

Trespassing around the back of a home

Front yard trespassing.

Trespassing on a private back yard that is not fenced.

Trespassing in a private back yard that is fenced.

Trespassing in a private back yard that is not fenced.

Lobby trespassing = Entering a building's secure lobby without authorization.

Sneaking in = Not paying for a movie, concert, private club, gym, etc.

Many nights of camping on private acreage without damage.

One night of camping on private acreage without damage.

Walking through livestock fenced acreage.

Shoplifting

Shoplifting-1 = Theft of expensive or repeated goods apparently for sale.

Shoplifting-2 = Theft of goods that are arguably for personal use.

Shoplifting-3 = Theft of low cost ingredient foods and absolutely necessary items.

>>>

When groups of shoplifters work together in teams, even when they are only in the store with another shoplifter they barely know, the penalty is doubled for conspiracy.

Graffiti rules

1/ The maximum penalty for spraying legitimate political messages on a surface that can be repainted is a fine equal to twice the cost of repainting. If the perpetrator has no money, they may be required to work repainting graffiti for half a day per 10 sq meters of their graffiti area that needs repainting

2/ The maximum penalty for spraying tags and non-political messages on a surface that can be repainted is a fine equal to 20 times the cost of repainting. If the perpetrator has no money, they may be required to work repainting graffiti for 20 days per 10 sq. meters of graffiti they did area needing repainting.

Campering

This is using a vehicle to sleep in an unauthorized area. Homeless people are like water. If you make it hard for them in one place, they just go somewhere else where life is easier.

Organized intimidation

Intimidating Americans on behalf of a foreign government or any sort of Mafia should get one life in prison.

Sloping the legal system away from criminal gangs

Small changes in the law can make most people afraid to join criminal gangs.

1/ It doesn't matter who pulled the trigger or caused the injury, or was in possession of stolen property. All who were present and/or publicly identified with the gang may be held to be accessories. This also includes females.

2/ Gang accessories should commonly be sent to hard labor and skills training camp for some months. Then they get a couple years of probation

3/ Gang accessories may be required to carry a probation phone for years after release.

4/ When crimes are committed by crime gangs of 4 or more, penalties can be multiplied.

Intervention and property crime

When a valuable thing such as a bike or lawn furniture is being stolen or ruined, and someone intervenes to stop the theft, they may shove, and also kick the legs of the thief and it shall be considered community self defense. However if the thief strikes back in any way, he shall be easily considered guilty of assault.

Custody abduction

This is the term to use when one separated parent seizes a child that is in the custody of the other parent and there is no conviction for abuse. This is a significantly lesser crime than kidnapping by strangers for ransom, or presumably sexual exploitation. The jail time for custody abduction shall not exceed twice the times the duration of the abduction provided the abducting parent notifies the other parent that they have the child.

No pre-trial jail for these crimes

The justice system shall not permit pre-trial incarceration for:

- 1/ The secondary crimes of criminal procedure such as perjury, lying to investigators, resisting arrest, interfering with an arrest, or interfering with an investigation.
- 2/ Slapping battery or virtual battery, even if against police.
- 3/ Speeding at more than twice the posted speed limit if this is over 30mph (50kph). If the speed is 25 or slower, the no-jail speed shall be 55mph (90kph).

Crimes revealed during a trial

- 1/ When crimes are revealed by a trial, these crimes may only be tried in a separate trial.
- 2/ The new crimes must qualify for a new trial based on the other crimes awaiting trial without any mention of the prior crimes in the complaint.
- 3/ The new crimes have a higher burden of proof for conviction
- 4/ These new crimes are generally subject to half the normal penalty.

Things that cannot be crimes

The National Senate should make a list of activities that cannot be made criminal by any county senate.

Skiptracing

It shall be a crime to offer the service of locating people except where there is a national court order or warrant, or the service is provided to a national police force, or to the military, or national or county tax house. Those who locate people, or reveal people in hiding that are subsequently killed or injured once found shall generally be deemed criminal accessories to those crimes.

Threatening witnesses or justice system people

1/ This can triple penalties whether this is done before people go to police, during an investigation, during the trial, or after the trial.

2/ The multiplier depends on the degree of intimidation.

3/ The multiplier also applies to third party agents and community intimidation.

4/ Third parties that help intimidate for others may get up to 10-years.

5/ Doing this for a foreign nation or the Mafia is subject to the death penalty

Police, jail, restitutions, and court funding

1/ These are three separately funded divisions of government. There should be no mingling or sharing of funds, equipment, or personal.

2/ The jails should cost nothing to society due to the captive labor force. But they should not make any money either, and all the profits should be invested in training and behavior correction. As well all the extra money goes to restitutions and crime prevention programs.

3/ The fine and adjudication fee revenue of the police, the jail system and the courts is to go to the general fund of the national government. Doing otherwise creates incentives that lead to corruption. Also, the income and expense aspects of police, jail, and the courts are two separate decisions. The money generated should have nothing to do with the money being spent. Indeed the money generated accrues to the national fund, while the money being spent to run these operations is paid by the local government thanks to an annual (or monthly/ tenthly) transfer payment from the national government to the various county governments.

4/ Like proper Buddhist monks, police are not supposed to raise or collect or touch any money themselves. Police are probably not even supposed to use municipal payment terminals. If money must be paid, let the citizen pay the court's website/interface directly and have the system sent the officer # a proof of payment message.

5/ The criminal-court and money-court systems should be separately funded and run. There should be no commingling of monies or staff, and they should use different locations in non-contiguous buildings.

Bribery expanded

1/ It shall be considered felony bribery to attempt to, or call for the justice system payments and settlements to be paid to any other than the government or plaintiff damaged in a case. This expressly includes all third parties such as individuals, charity's, and other types of fictional citizens.

Police

How to end BLM

Part 1: Dumb drug and weapons laws

- 46% of Chicago incarcerations are for the drugs that are totally endemic.
- 20% of Chicago incarcerations are for weapons possession.
- So in Chicago, about 2/3 of incarcerations are not for actually harming somebody, but for things that might harm someone. And these convicts that might have hurt someone outnumber the convicts that actually DID harm someone by 2-to-1. Here we see the absurdity of our nations drug and weapons laws.

Part 2: End money bail

1/ Money bail is unjust because it hits the poor more than the rich.

2/ Money bail is unjust because the 10% bail bondsmen fees penalize the innocent. A 500,000 bail bond costs \$50,000.

3/ Penalty multiplication is the main thing driving people to come back for trial. The amount of money people deposit with the court doesn't really assure their return for trial, and it should have nothing to do with whether they are released pre-trial.

Part 3: A national code of police conduct

What can police do, and what can't they do. When can they search a person? When can they order people out of their cars? When can they take their guns out? When can they break your car's window? Let's all know what the rules are.

Part 4: Stop killing people to avoid civil lawsuits. This however, is more of a problem with the nations's civil law system.

Police hatred is mostly from the war on drugs

Isn't this is the main reason for police hatred. Isn't this mostly from American's failed drug policies. And won't this hatred shrink greatly once we legalize drugs.

Heroin holes

I would use the old jails to house CTD junkies. Before getting a heroin license, the last thing that people should have to is go and talk with the junkies in a H-hole. These get to share a 2-bedroom apartment if they can get one person a month to hit the start-over button on their heroin license program.

Clear rules or non-lethal weapons

We need rules like no-non-lethals when people have their hands up or are mostly lying on the ground, or in handcuffs.

Fast release tear gas

These discharge lots of tear gas real fast and get too hot to be thrown back.

Sedative darts

Maybe the police also have sedative dart rifles in their trunks. To me, debugged sedative darts seem the most optimal way to go. They certainly have much greater range and accuracy compared with tasers. These replace the barbed darts of the with barbed hypodermic needles that cannot be readily pulled out. I imagine a large diameter throwing dart perhaps as large as a short cigar tube, or test tube, not counting needle or fins. This is electrified like a hand shocker so people can't grab it without electrical insulation like a rubber glove.

>>>>

These are like the ones they used in the "Wild Kingdom" TV show 50 years ago, but they have a WIFI connection between dart and riffle. This is used to run:

1/ A connection confirmation via electrical impedance and alert chirp

2/ Variable injection amounts.

3/ Confirmation that the injection was completed.

4/ Additional incremental dosages can be dialed up from the rifle.

>>>>>

These darts might default at a does of 15% of lethal dose for a 50kg (110lb.) person. Although perhaps the officer can turn the initial dosage up to 20, 30%, 40% or 50% depending on the size of the target individual. The officer can also step up the dosage until the person is down.

>>>>

Then they send a delivery confirmation sound if that happens. And these have barbs like the taser rounds. And maybe if the first dose is not working, the officer can turn a knob and deliver a 2nd, and a 3rd and a 4th does until the person is down.

>>>>

Tasers result in lots of head injuries due to the way people fall. Incremental doses of Injected drugs are a much safer way to take people down, even considering adverse reactions. Darts have a better distance.

Shooting looters with rock salt

There doesn't need to be any warnings. They can simply be shot in the lower half with government approved rounds for that type of leggings: shorts, trousers, jeans.

Police shotguns

1/ The police shotguns need to be foolproof about which shell is inside. There needs to be daily verification of the sequence or a clear window to the shell compartment.

2/ The different sorts of shells all have different colors, internationally identical shell colors. Maybe the colors are Day-glow yellow for rock salt, Orange for bird shot, and red for kill rounds.

Shooting looters

During riots and natural disasters, crisis law rules. Those who break into occupied homes, or occupied businesses (other than grocery stores and gas pumps) may be shot

dead in any numbers without warning by the defenders. This is necessary to help maintain order.

Quick release of police shooting videos

In general, all police firearm camera data should be made public within 24 hours. However, the officers involved and their department may provide narration with the officers or their commanders explaining what happened.

Standardized rules for officer conduct

There should only be one code in the US. Especially with regard to arrests and weapons.

Once you draw a gun on police...

Can someone reenact the video from the McCreary police shooting in Phoenix? But there are two endings. In one she keeps running, but in the other she turns and fires 11 rounds at officers. Play one ending then play the other randomly. Do it a few times. There is no way to tell what is going to come next. The rule that officers may never fire at someone running away is clearly too blunt.

>>>>

When officers can't fire, crooks know this and are more likely to run, turn, and shoot. Then the people have trouble finding good men to be officers. This is why we say that when people draw on officers and run away, they may be shot

No unlogged weapons or seizures

1/ We don't want police carrying around extra weapons to frame people with Police may only carry logged weapons, even clubs, either on them, or in their car.

2/ All cops and their vehicles get randomly searched for extra weapons and contraband at least annually. In places with law-enforcement corruption issues it should probably be every 90 days or even more frequently.

3/ Police may not come in possession of any evidence that has not immediately declared into the recorders video record.

Widely ignored laws & police corruption

There really should be some constitutional rule prohibiting ignored laws. This is because when we have laws that are widely ignored, police gain the power to bust citizens at their option. And that is a thing that is hugely corrupt. It certainly violates the spirit of our constitution and legal system.

>>>

We don't want a system where if "they" want to get you "they" can always find a way. We in fact want our legal system to go as much as possible in the other direction. And we want a constitutional prohibition on laws that are widely ignored for this reason.

>>>

Also, it should be pointed out that with widely ignored laws, the secondary problem of police injustice is normally far worse than the benefits that the widely

ignored laws would bring — even is if they weren't widely ignored.

>>>>

Lower penalties will be used more

The severity of the penalties creates a threshold, and people don't want to see someone go to jail for a decade. Having faster trials and lower penalties will fit hand in hand and give the law greater reach and force on the margins.

Anti-crimes

These are things that cannot be crimes. These are things that law makers and law enforcement people get in trouble for enforcing.

Brandishing arms around one's place

This is allowed when gangs of people are roaming the streets and there is widespread shooting, killing, burning, beating, looting or rioting. Or when gangs come to a residence or business (a "place") in a way that is confrontational. In all these cases, the defending residents/workers should be free to be armed on and around their premises. Also when the people in the gangs are brandishing firearms, or have flames or rag bottles, or clearly threatening violence, or demand money, those with the firearms, flames, or rag bottles, and those threatening violence may be shot by the defenders without warning. They may also have a firearm pointed at them.

Cops confronting armed shooters

None of these guys should ever come with a handgun. This is ridiculous. All should have scoped rifles

Firearms

Due to training, police pistols may fire at a faster than normal rate and not be considered militia weapons.

Police temper testing

I would test all police cadets for their temper. And with female cops I would do that at that time of the month.

Arrest classes

A1 = Murderous, or firearm use

A2 = Violent history

A3 = Everyone else

Police are allowed to take reasonable precautions when they have reasonable cause to think they are in an A1 and A2 situation. Also, statistics for A1 and A2 arrests are separately tabulated from overall arrests.

Minimum enforceable speed limit

This is 30mph (49kph) except where a hazard exists on the road such as a sharp corner, or sharp crest, or a blind intersection.

We got him on a weapons violation

This is not the way the legal system is supposed to work.

Publishing data with intent to cause harm

This is a crime

Citizen ID

All government identification shall indicate whether the person is a citizen or not.

How do we punish police?

1/ Don't punish police for legitimate mistakes and bad split second decisions even if people die. If it is a close call, we must err on the side of forgiving them, or we will not find good men to be our police. It is very simple.
2/ What do we do to them when they are moderately bad? Do we fire them? Do we disgrace them? Do we fine them? Do we make them police bad neighborhoods? Do we do nothing?

The 911 app

This is mandatory on all cell phones. It makes no sounds and has a medium brightness screen which can be adjusted by a slide at the bottom. The app has buttons across the top, fire, police, medics Then it has 3 level of emergency buttons and a text box for conditions comments. It also has a GPS with location comments. The texts are viewed by a dispatcher which can censor, but generally allows any texts that might be helpful to be spoken into the ear-buds of the responders. The dispatcher can also forward audio tracts for the responders. Thus the people calling-in are able to get messages the responders directly, and these should have a means of calling the people in each message back. In fact the message stream play on their headphones but it appears as a chat in their phone which has something like a twitter stream, but the info is all centered around some emergency situation. We also imagine situations like people in the front yard with their kitchen on fire sending the video to the dispatcher which hits the forward button to the arriving fire truck.

Bezel cams

All phones should have a third camera at the edge or bezel for casual filming. Also your video backs up to 811 Then the police HQ sees what you are screened on and your location

Police

Emergency services are funded by the county, and there is only county police and national police. The county police are directed and reviewed by the county Senate.

I don't think it is the police they hate. The police are just the interface for the penalty system. I think they hate the world that is leaving them behind to live with roommates

and perhaps to be arrested and socked with thousands of dollars in legal fees.

Vehicle license plates

Perhaps given how easy it is to paint on the vehicle itself with printers... perhaps we should stop using license plates and switch to direct painting on the top, back and front of all cars and larger vehicles. We use special paints and that can only be applied by the DMV. The number for each vehicle perhaps never changes, only the ownership.

Gun license plates?

Maybe all carry firearm should be required to display serial numbers in large text in a contrasting color.

The police commissioner

1/ How many times have we seen this person features in US media?
2/ It should be a police commission of many people, not a single police commissioner.
3/ This group does not supervise the police. It evaluates and judges public claims against the police.

Door ID

Wouldn't it be nice if there was this county operated RFID video door bell. Thus visitors could put their chip on the scanner and the device would send the number to the recorder and it would show their ID photos. So the resident can compare the image on their screen with the person at the door. Maybe there is an option that all the people coming to your home have to make an appointment using the ID verification system. And maybe you have to accept before it is legal to visit you. Maybe they can't get out of the township public area without someone accepting their ID.

10 cents for ID verification

Shall we charge people for ID verification, or make it like Google searches? We should make all our electronic services free to use.

Of vehicle networks & crime getaways

If all the vehicles are controlled by a network, how does one get away from the scene of a crime using a vehicle.

Crimes by door to door salesmen

The penalty is doubled, and tripled if they come back to commit the crime. And they are still not allowed to go to people's homes.

Demonetize Brazil

Demonetizing drugs and getting rid of cash will affect the most dangerous nations the most.

Provisioneering

This is when people in a crisis situation take reasonable amounts of essential items like food, gasoline, and needed medical supplies.

When thugs with records loot

When people with criminal records engage in political violence, or disaster looting, or disaster violent crime, they may be sent away for life. (Looting here does not include provisioning reasonable amount of essentials)

EMS screw up liability

There shall be no liability when trained rescuers working for government screw up in crisis situations. This shall include firemen, police, paramedics, air rescue and emergency room healthcare. You get what you get with all these services.

My sort of Western

There is this huge fearsome band of 30 men that comes into some dusty town and takes over. They take whatever they want including the women, most of which have men. Maybe they kill a couple people to prove how deadly they are. Then, with some of the women on their horses and some left behind raped, they get on their horses to ride off. But just then, we realize that most of the towns 100 men have grabbed their rifles and have run up to the road and onto the roofs. Then someone yells fire, and then a second later, the entire town cuts the bad men down in one volley from all their rifles.

A good example of what police uniforms should look like, but perhaps with smaller numbers.

Dayglo yellow British tops are another good idea. They will help rebrand American police as nice and helpful in the wake of scrapping our old drug laws, money-based bail system, and vehicle stop and ticket system. 1/ 46% of Chicago incarcerations are for the drugs that are totally endemic.

2/ 20% of Chicago incarcerations are for weapons possession.

>>>>>

So in Chicago 66% of incarcerations are not for actually harming somebody else, but for one of two activities that supposedly leads to harm to others. >>>

So we are tripling the number of inmates and ruining the lives of hundreds of thousands of people in the US. We are pissing away billions of dollars for prisons. What are we getting in return? Are we reducing drug use any more than taxation would? Are we reducing gun violence by much? We are certainly making part of America hate the police.

Roman homes, American arms

This is the safest way to live. The wood and glass houses of America are not terribly safe. The arms help, but they should be rifles more than pistols.

Police software upgrade

Police are not responsible for knowing the law completely. However they must learn the reasonably easy things the Senate tells them they must learn. And they must pass the test with a 100% score, like we do with shop safety classes.

Police assemblies

I would send cops around to the schools to present these assemblies on:

1/ We cops are just like you.

2/ We have a job to do. We don't hate people, we are just doing our job.

3/ How the word "Freeze" means that the cop is going to shoot you if you don't freeze perfectly still".

4/ How "Hands" means that they are worried that you have a gun in your hand and are about to shoot you.

Hands means hands up or you are about to get shot.

5/ If we say you are under arrest, you have to give us your hands right away or you might get either knocked down or shoved against a wall... perhaps on top of getting a longer sentence.

House call magistrates

The various counties should offer these as a paid service at perhaps 7x the average wage per hour. These are like the teacher monitoring the playground.

National databases of accusations

We should know who is getting lots of complaints.

R'21.18 altered as follows: Police nationwide shall wear one of 12 standardized uniforms that all look roughly alike except for the emblems and badges. Unless a police officer is wearing one of these uniforms, or accompanied

by someone wearing one of these uniforms, police shall not have the power make arrests or order the people around. This rule however does not apply when a suspect or multiple people from the neighborhood know the officer as an officer.

Police priorities

Police protect us first against murder then injury, then violence, then threat of violence, then grand theft, then petty crimes.

Body cam that don't work

- 1/ If the camera is off, or not in live backup mode with the recorder, the arrest shall be void, just as it was under the most restrictive construction of the Miranda rights.
- 2/ If the officer's camera is off when the citizen is harmed the presumption of guilt is on the officer.
- 3/ The camera rules apply to police, building inspectors, fire marshals, lifeguards, child protection services, and all other government people using any compulsory power over the people.
- 4/ Where one would expect the live backup camera record to evidence of a crime, the camera record must show evidence of a crime or there can be no conviction.

Nazis officers were given meth

Giving war fighters drugs may improve survival, but it also leads to accidents and war crimes, right? I wonder if police on caffeine is also a bad idea. I mean shouldn't they be as calm as possible? Maybe we should go back and look at all the police officer shootings and correlate them to caffeine consumption. Is there a relationship?

Child protective services

- 1/ We are a land that errs on the side of freedom and tolerance in the way people live their lives and raise their children. This includes how much of a "free range" young children are allowed.
- 2/ If there are any rules about what is not allowed of parents, they must be adequately promulgated by government.
- 3/ Our legal system is based on physical evidence and not the subjective opinions of police officers. CPS must provide clear and definite evidence to a judge to take non-emergency action.
- 4/ As with police, all CPS communication with the people must be publicly recorded under chest cam or recorder video phone line.
- 5/ Minors shall not be interviewed by CPS without parental permission unless it is under a court order.
- 6/ All children's interviews shall be recorded under remove backup by the recorder's office. No leading questions may be asked either before or during the interview.
- 7/ Our school system will take and board kids at a much younger age. In fact there may be special schools for

"early removal" kids, so CPS will lose most of its jurisdiction.

8/ CPS must have a court order to remove children from a household.

9/ If any court motion is denied a CPS worker, that worker must hand the case/family in for re-assignment and they (and their associates) may never work on that case/family again.

10/ All CPS workers shall have an intervention ratio and a child removal ratio.

Less crime

- 1/ Eliminate cash and fungibles to make crime harder to profit from.
- 2/ Drug licenses, and free, safe, legal drugs where people pay with hours spent watching anti-drug media instead of paying the Mafia with money.
- 3/ Mandatory bezel cams in all phones. Then nobody knows who is recording and sending to the recorder and police when they are holding their phone normally.
- 4/ 811 = police record, watch & perhaps dispatch.
- 5/ Free public kid tracking.
- 6/ General abundance.
- 7/ Better education.
- 8/ Townships with ID verification for all guests.
- 9/ Eliminate human operated vehicles from safety zones at least. Getting away thus becomes hard.

Lawyers & Court

The presumption of innocence

The presumption of innocence should be strongest among those with no prior convictions. Then it should diminish until we reach hardened criminals who have lost much of this right due to multiple convictions for non-political crimes. As well, the presumption of innocence shall be weakest among those with apparently air tight cases against them, especially those caught on public video and in front of many witnesses.

All legal settlements must be reported

To prevent fraudsters, it should be a felony to settle a legal claim without making a declaration to the court. This way, those who go around pretending injury to make money on settlements are rapidly caught. Also either side may be charged for making and undeclared settlement.

Why there must be an underlying crime

There is a reason we need to require an underlying or primary crime in order to have convictions for crimes of the judicial process such as: obstruction of justice, resisting arrest, misleading investigators, contempt of court, and lying to prosecutors. The reason is that without an underlying crime we risk having police and government people hauling innocent people into the justice system on flimsy charges. This in order to try to get them on an error, or a procedural charge, or an

inconsistency in their testimony, a lie. These types of crimes are not for free people in a free nation. They are instead things of Places where the people are subservient to their government.

Crimes of criminal procedure

These shall generally not be disqualifying felonies. They may have long sentences, but they shall not be felonies.

Tampering

When those charged with crimes communicate with witnesses to their crimes, or their accusers, their communication must be recorded.

All Senate pardons are a full and total exoneration

Unlike the make believe pardons the US uses today.

Double penalties for injury against police.

Triple penalties for protest violence.

Quadruple penalties for violence against leaders.

The power of the law

It's quite obvious, but it still needs to be pointed out: The law only has limited power over changing behavior. This is why making drugs illegal doesn't stop drug use. It's also why outlawing adultery doesn't work. The law can only bend behavior to a limited degree in a free society. If it exceeds that bend, people ignore the law. So lawmakers must make laws that are gentle curves that are obeyed, rather than sharp curves that are ignored.

National judicial oversight

1/ Some parts of the country are on the long tail with regard to "progress" or "progressive-ness". For example San Francisco. Other parts are on the other long tail with regard to traditional-ness like say Montgomery AL. In recent decades, both communities have clearly applied the law in ways unacceptable to the remainder of the nation.

2/ We do still see corrupt prosecutions and corrupt pardons on the part of local governments.

3/ A double checked legal system is probably a good idea where the national sense of justice is affronted. In other words, the national courts have the right to overturn county judgements and stop prosecutions.

4/ If the county fails to prosecute, the national Senate may.

Under oath

Everyone must tell me the truth when I ask them a question.

A slight legal immunity

There should be slightly higher standards for bringing cases against: Ubigs, Main-Senators, and Over-senators

for both Criminal and money court. This especially when they have done things that anger a constituency.

My personal immunity as a prophet

I have said a great many things. Some of these things will certainly anger some. Many may think they can get rid of my changes by attacking me.

1/ I may never be charged, subpoenaed, deposed, sued, harmed, de-platformed, moved, or punished for anything I say, even if it is deemed racist, sexist, transphobic, or treasonous. Anyone attempting to harm me in such a way should be punished by the law.

2/ Nobody shall be free to take the most controversial parts of my message and re-assemble them so my message looks more controversial than it is.

3/ Nobody shall be free to take the dumbest parts of my message and re-assemble them so my message looks dumber than it is.

4/ Nobody shall be free to substantially alter the context of my message.

5/ You are free to disagree with what I say, to call it wrong, but you may not attack me personally

6/ Only the American Over-Senate shall have jurisdiction over my actions.

7/ I may go anywhere on earth I want, and stay as long as I want without a visa.

Feelings and the law

People's feelings should have no place under the law, as feelings are subjective and the law is supposed to be objective. Therefore any law that makes mention of feelings should be unenforceable.

Politically motivated prosecution

When it is judged that people abuse the legal system for political reasons, or to harass someone or some group — when it is judged that this is more than 2:1 of the reason for a court action, they might have to pay punitive damages, or face charges for fraud. Also, perhaps all court filings should include an oath that the filing is not for political purposes, or in vengeance or to intimidate others.

Bald shoes

People know well enough about bald tires, where the tread is all worn off and the tire isn't functioning properly. People wearing bald shoes, shoes they know they're slippery, especially if they're designed in such a way that is inherently slippery or unstable, these people should have limited rights to compensation if they slip somewhere. Likewise with unstable high heels.

Eggshell skull plaintiffs

Today defendants are liable for injuries to plaintiffs with rare special conditions that aggravate their injuries. This

is another legal rule that exists because it causes more litigation, vastly more litigation. This rule benefits mostly the legal industry, and burdens our nation greatly.

To my mind hemophiliacs needs to Take special precautions, and must exist in the world of normal people. It's wrong to have a society that goes way out of its way to take care of hemophiliacs and people with bad balance and people who might have slippery shoes and the like. This rule should not exist. It is not much fairer to have it, But it is much more costly, and it does vastly increase the need for court procedures.

Instant video adjudication

Most consumer products and services should be subject to instant video adjudication. This is where you video call a county specialist adjudicator and pay \$2/minute for talking and video showing. The winning side does not pay, and half the money (~\$30/ hour) goes to the county adjudicators working from home on call.

Not using a form contract

If you're not using a form contract, perhaps you need to submit your contract to the county law library to make sure that there are no conditions that are likely to lead to dispute or conditions that are unenforceable, or conditions that are biased against one side or the other. Here I imagine administrators that are like escrow officers reviewing the terms of a sales agreement. These are paid by the Thousand words to review the contracts. Maybe for a contract to be valid, it must be either from the county law library, or accepted by it. Surely we don't need lawyers to make new contracts for us.

A unified court system

We need to unify and simplify our nation's court processes. There should be one set of base rules nation-wide. If any county wants to deviate from this, it must gain approval from the national Sub-Senate for the legality of its deviances either prior to local passage, or during say the first quarter of the required effectuation delay period. Each county with deviant laws must also web-publish an annual list of all local deviances. Finally, the total number of deviances should be restricted where there is not some special local factor that necessitates a large number of unique local laws. For example due to the density of Manhattan, or the big border crossing towns, or the special foreigner presence on the Big Island of Hawaii, or on the witness protection islands.

Appeals

The current legal system makes multiple appeals a right to the person who has been convicted of a crime. Thus there are two (or more) defense trials for the defense lawyer industry to feed on. And that's why the system works this way. It's lawyers pushing legal accuracy at any

cost to their clients, Costs that they will receive as payments.

Courts will grab power too

Courts should neither create laws, nor substantially modify, or interpret, or execute laws. And if there's a problem with the law being vague, or having multiple interpretations, or being apparently unconstitutional, the court's only power is to ask the legislature for clarification or correction.

["A ship has a legal personality, fiction found useful for maritime purposes... so it should be as respects valleys, alpine meadows, rivers, lakes, estuaries, beaches, ridges, groves of trees, swamp land, or even air that feels the destructive pressure of modern technology and modern life... The voice of the inanimate object, therefore, should not be still."](#)

[1/ Here is a US supreme court justice giving rights to environments, this then lead to many of our richest mineral deposits being put off limits. It also caused our cities to grow around many central parks, thus increasing sprawl and sales of OPEC's oil.]

Vision is not judgement

The people who contribute the most to the group cause might not be good judges of

Democracies can only change the rules for the next time

The way the House democrats have changed the rules for impeachment should only be applicable for the next time. The current impeachment needs to use the existing rules.

No court transcriptions or stenographers

Instead, there is central monitoring and recording in multiple, and HD audio and video inputs.

The prosecutors first duty

It is to justice, not conviction. The hiding of evidence by prosecutors should be a felony.

Epstein sex scandal

These accusations of sexual impropriety decades ago are almost impossible to refute. So anyone can be gotten rid of. So you will never have another good leader again. Because all can be easily dispensed with via this nonsense.

Alzheimers judges

There should be standardized cognitive decline tests. These should be administered by people who have completed a 6-month internship with another Alzheimer's

judge. These should be employed by the public to gauge people's age-related mental decline.

These people shall judge when people must get review for:

- 1) Making big ticket purchases and investments.
- 2) Their right to undertake legal matters.
- 3) Their right to roam around alone because they have gotten into trouble before.
- 4) Their right to take care of themselves.

Perhaps once a person reaches age 70, they must go for annual review.

Bad laws feed Lawyers

A Senate maxim

Lawyers, reputations, and status

Society should not allow any ranking or reputation scores for lawyers as it encourages a costly arms race in lawyers. Also, all lawyers shall keep their offices in a monitored court house annex. All offices shall be identical in each court house. They may vary between court houses, but at each site, the offices must be identical. The corner offices are for conference rooms. Lawyer offices cannot be on either the ground floor or the top floor. Total equality of office space.

Lawyer that become businessmen

Those who have completed half a year of law school or more, may never represent themselves as a plaintiff in money court. And if they have associates that are lawyers, these may not act as plaintiff's lawyer. This also helps lower the status of lawyers so fewer of our best people go into law.

Lawyers and the truth

Under today's legal system, it is said that lawyers may not deliberately mislead the court, but they are not obligated to tell the whole truth. Yet when people take the oath of truth before appearing in court, they must promise to "tell the whole truth and nothing but the truth". Why is it that clients are required to tell the whole truth, but lawyers are allowed to tell part of the truth? Doesn't this give an advantage to lawyers, and those who hire costly lawyers? Why do we give this Advantage to lawyers? The answer is simple, it is simply that if we didn't do this, fewer people would use lawyers unless they had to.

How to have fewer disputes and less crime

It is very simple, kids should be taught the law in school.

Senate immunity

This applies to all candidates, everyone waiting to begin Senate service, all sitting Senators and for 6-months after leaving the Senate.

The statute of limitations

- 3/ What if non-lawyers always got to speak first and last?
- 4/ What if the non-lawyers got a bit more time to talk?
- 5/ What if the non-lawyer got to set the trial duration within a range?

Inclusion trumps accuracy

10x more lawsuits
10% of the time each

There won't be any "judges"

There will only be Senators who probably never worked in the courts before.

No shopping for judges

It is wrong the way politically charged cases are frequently shopped around to the various judges and prosecutors. Firstly, the decision to prosecute is a matter of the County Senate. And secondly, if a case is turned down by the County Senate, that is the end of the trail, unless the national Senate decides to prosecute.

Double Jeopardy

This clause in the US constitution wasn't about sentences. On the host side, it was about keeping the those in power from repeatedly trying people as a means of harassing them. But it's real reason to exist is that on the parasite's side it helped get bro's acquitted when everyone knew they were guilty. So I think the Senate should be free to re-sentence the worst criminals to death when they are wrongly acquitted.

Open and shut cases

We have all seen real-world high-speed car chases where they call out the video-helicopter and there are over a dozen arresting officers, and the driver is being led from the stopped car on live video.

1/ Clearly due to the probability of guilt, the driver does not get release on bail.

2/ Why are we having lengthy trials in cases where there is clear and incontrovertible video evidence, or multiple eye-witnesses against some ordinary person?

3/ Maybe we call on 5-Senators on jury duty, and if they all hold that the accused is almost certainly guilty given the video evidence and testimony, then the accused is not released on bail and sent straight to sentencing, unless they need time to prepare their case.

Police videographers

These people go around to the witnesses at a crime scene tripod recording the statements of witnesses, and the evidence the witnesses and officers show. They are armed, and all video is live recorded.

Spoken hearsay exemptions are no longer needed because

1/ Past sense impressions must be in writing, or video or audio recorded at the time to be valid. Spoken statements about spoken statements are never valid.

Also, regarding written impressions, they are only given credence because of their detail, regularity, and lack of inconsistency.

2/ What a gotcha society this rule fosters.

3/ If you witness an event, the event dialogue is admissible as part of one's first-hand testimony. However, if someone tells you they committed a crime, that is not admissible as evidence.

4/ Medical records system function, not hearsay.

5/ See #1 above.

6/ See #1 above.

from the outside world, it may never seal this information from itself, or destroy this information.

23/ See #22 above.

The rules of hearsay add a great deal cognitive overhead to the legal system. But they add little to legal accuracy. In fact they make the legal system more a thing of hired guns who have mastered this abstruse subject. So let's scrap most of them and reinterpret the survivors to other parts of the legal code.

Also, as soon as the recorder system is up, all court admissible written records of spoken words WRSW must be made on the recorder's un-erasable boards to be valid. This CC's all subjects of the record and allows for reply statements.

After this time, all WRSW must be on never-erase logging board. And while these WRSW files are admissible, they still should be doubted a bit.

What people say to others is not admissible ever. Telling somebody something in the past it's not evidence of anything in court. It may be grounds for a criminal investigation, but it should not stand as evidence in court.

Worthless distinctions

Why do we have judicial distinctions that only experts can understand and properly argue. Surely this sort of stuff was created by lawyers to help lawyers.

Unlawful detainer court rules

1/ Apartment managers and UD legal services may appear as principles.

2/ No lawyers in residential cases.

3/ No limits on multiple appearances.

UD protection side effects

I completely understand the reasons for having strict unlawful detainer (eviction) rules. I just think they are better reasons to treat weekly rentals like hotels.

1/ These eviction rules are really expensive for the poorest part of society, and those who have had a financial disaster. These people have a much harder time finding housing, except in bad neighborhoods.

2/ At the bottom of society, many people are unable to find housing and become homeless partly as a knock-on result of unlawful detainer regulation costs.

3/ People are much more reluctant to rent places for short periods of time, and this is a huge cost.

No unlawful detainers here

As I've said before, Weekly rentals should be subject to the rules of hotels, i.e. the tenant may be evicted and ejected at any time by the landlord if they don't follow the rules or don't pay. There should be some other areas that should be excluded from both court and the unlawful detainer process:

1/ Residential tenants documented having loud parties or playing loud media after 9pm.

2/ Tenants with certain high use alcohol or mafia drug licenses.

3/ Tenants caught on video intentionally damaging the property.

4/ Tenants without a written rental agreement.

5/ Roommate tenants that live in the same premises as the property owner.

Divorce adjudication

If the parties can agree, that rules. If the parties can't agree, then a blind adjudicator looking at nothing but the assets and assessed values, together with their instructions and list of wanted items (in order) of each party splits the assets.

Divorce book-keepers not lawyers

The people dividing the assets should be inexpensive book-keepers, not expensive lawyers.

The one minute rule

The defendant must always be given the time to speak at all trials for at least one minute for every year of potential sentence up to 20 minutes for life in prison, or death penalty charges.

Asbestos toxicity in talc

Once upon a time, when asbestos was mined and processed, it was floating around at perhaps 10 or 100 times the density of rag weed's maximum in these places. So workers would be pulling clumps or the stuff out of their mouths and noses. Asbestosis mostly comes from this sort of exposure level. The levels of asbestos exposure from talc would appear to be many thousands of times lower and of negligible risk.

The middle path for lawsuit payments

The parasite likes either extreme. On the "right", Ishtar is happy with the China-2020 & USA-1870 approach where people harmed by companies get nothing from the system. And on the "left", Ishtar is even happier with the \$80-million awards to people because they developed lymphoma after using a chemical that is apparently as inert to mammal metabolisms as is say dish washing detergent.

Roundup Hypocrisy

Cigarettes kill 480,000 American a year. Of these about 15% of Americans die from second hand smoke, or about 72,000 people a year. How can we award people \$80-million for an unproven relationship that doesn't make sense to most organic chemists, but we still allow a proven carcinogen in our cities?

The limits to secondary crimes

Secondary crimes may not increase penance for primary crimes by more than 50%, and generally it should not be more than an increase of one third.

Lawyers are not allowed to work in obtaining government approvals.

A corrupt Supreme Court

To see the corruption of the current US Supreme Court, simply look at the timing of the 1973 Roe vs. Wade decision, and how it preceded the 1973-77 Arab oil embargo by about 11 months. Regardless of how you stand on abortion, you must admit that this decision caused many more people to be more distracted by sex just before the oil embargo hit.

What do lawyers have to do with justice?

Political crimes and access to media

When people are imprisoned for crimes that have anything to do with government officials, or important people, they shall never be deprived of their right to regularly communicate with members of the press for a reasonable time to fully explain their situation.

A justice system bias against political partisanship

1/ Politically active people may not be prosecuted for crimes unless the crime is being widely applied to non-political people.

2/ People with extreme political views must recuse themselves in matters of their political opponents.

3/ Those who engage in politically motivated prosecutions should serve 3X the penalty they are accusing their opponents of.

Esoteric law rule

If a law is not fully understood by at least 3/4 of incoming Sub-Senators, it cannot be enforced.

Honest services fraud

This is a pretty good example of a law that is so esoteric and so hard to understand that it should not exist.

No law dredging

If a law is only dredged up to jail people that police need to jail, then it cannot be enforced.

Criminal convictions are not evidence in money court

Criminal convictions may not be used as evidence in money court as this incentivizes people to accuse the rich of crimes so they may later, in the second stage sue them for profit.

School crimes

School is not real. It is a practice and training period before life. If you cheat on a government test, it is a

crime. But if you cheat on a school practice test, or you lie on your school entrance exam, or you copy someone else's work at school, the worst thing that can happen to you is that you get kicked out of the school.

Biden's totally independent justice department

It won't even have a democratically elected person in charge.

No liability for helping

There shall be no liability when trained rescuers working for government mess up. This shall include firemen, police, paramedics, and air rescue.

Baseless prosecution

It should be considered a crime akin to forgery or perjury to bring a baseless or abusive proceeding against a person. This should include cases that one knows will fail, such as the recent impeachment proceedings.

Becker's rule

When a law is being enforced in a new way, the accused may not be held in jail for that crime until they are convicted.

Bail, Arrest, Prison

Bail

Blackstone's ratio

"Better that ten guilty persons escape punishment than that one innocent suffer."

Money bail is corrupt

- 1/ The innocent must pay a pile of money to get out of jail pending trial.
 - 2/ It falls heaviest on the poor.
 - 3/ It gives police power that does get abused.
- Multiplying sentences is a better stick.

Failure to appear in court

Depending on the severity of the FTA, The penalty will be increased by somewhere between 10% and 500%. This is much better than money bail for assuring that people will return for trial.

Denial of bail for the arrested

- 1/ In the interest of public safety, bail may be denied for any of the following reasons:
 - A/ Flight risk.
 - B/ Clear risk of harming others or the community.
 - C/ Those who are almost certainly guilty of the crime given credible evidence, such as public recorder videos, a large number of sworn stranger eye-witnesses, matching blood, a weapon with matching ballistics.

D/ Those who seem likely to commit more crimes again, considering their criminal record, state of mind, and prior activity.

E/ The accused is an illegal alien.

F/ The accused has a prior felony conviction.

G/ Three prior misdemeanor convictions.

2/ However, bail shall generally not be denied for crimes related to non-violent political activities, or non-violent protest. Also, bail shall generally not be denied for well known leaders of all sorts, even when many people hate them.

FTA penalties

Over a day = 10%

Over a week = 20%

Over a teneth = 50%

Over a year = 150%

Over 3-years= 200%

Over 6-years = 300%

Over 9-years =500%

Arrests

The right to know what you are being arrested for

When police explain their arrest, they don't have to name the section or even the law broken. They can just say something like: "You are in possession of stolen property", or "You have a mafia drug without the proper license."

Interfering with an arrest

- Bystanders may be arrested for any of the following
- 1/ Attempting to block officers in pursuit of a suspect.
 - 2/ Being part of a crowd that is menacing an officer making an arrest.
 - 3/ Group resistance to an arrest.
 - 4/ Entering an arresting officer's security space of 6 paces while he is making an arrest. Once a person becomes aware of the arrest they must back up to 6 paces, unless they are simply unable to.

Good conduct with the police

Police should be able to make complaints about citizens that say insulting, taunting, threatening things to officers. Then a Sub-Senator gets randomly assigned to view the clip and say whether the person should do 100 hours of community service.

Imprisonment

Prison bias — lengthy, or grueling

We should distinguish between removal crimes and punishment crimes. The violent and sex crimes should be considered removal crimes where we err on the side of locking people up for longer in greater comfort, because we are more concerned with their removal than their punishment. For stealing, we don't want to lock people up

for as long, but we want the punishment to be worse. And maybe the increment is not that great. Maybe the time difference is only 40% or 80%.

Fewer people in jail

Ex-convicts should be walking on eggshells around seniors, kids, travelers, disabled people and the like

Internet in jail

In the work camps there will be internet for the inmates at night. But in the straight jails and prisons, there will be no cellular or internet service within range. Only jail communications may exist in this zone.

Prison time

It will not be awful due to violence and domination. It will be awful due to an intentionally exhaustive work and education schedule. Instead of being idle all day long, prisoners will be busy all day long and have almost no time for their own thoughts. And they will be constantly reminded of how much money they would have if they were working this hard as a free worker.

Standard education pardons

- 1/ Those who have not completed high-school prior to their conviction shall get 5% off their sentence for completing their high-school equivalency test.
- 2/ Those who complete 14th grade get another 5% off their sentence.
- 3/ Those who complete 16th grade get another 5% off
- 4/ Those who get certified as a journeyman worker shall get another 5% off their sentence.
- 5/ Those who do not behave well while incarcerated will not be allowed to take their final tests.

A limit on pardoning power

Only legislatures can change laws and only changes in the law can pardon a whole class of criminal.

Inmates should work long hours

- 1/ Their labor is a good revenue source. This money can be used to fund the corrections system and for restitutions and court costs.
- 2/ One's debt to society is literally paid in money while one lives as a prisoner and see almost none of the money.

3/ When they are released they'll have skills and be habituated to working long hours. Thus it will be easier to get a job than to go and commit a crime.

4/ If they do their jobs well, exceptionally well, they'll get their own prison cell, and reduced work hours and more school hours. There's a couple levels below, then it's awful work, then it is lockup.

Honest democracy & prison labor

This is another area where having an incorrupt government is just so much better. It seems that we don't actually trust our current democracy, or republic, or whatever we are going to call it. So we have the secondary prohibition on prisoners working. But if we had a believably honest democracy, we could put our prisoners to work.

Probation phones

- 1/ you gotta carry it at all times.
- 2/ It is constantly recording, and can be monitored at any time.
- 3/ It tracks your location.
- 4/ You are not allowed to use other communication devices.
- 5/ It tells you (and your probation officer) when you are going somewhere you should not go, like drug dealer parks, kid zones, etc.
- 6/ Police and probation officers will drop by at random times to check on you.

Jail is supposed to get worse

It is supposed to get worse and worse each time you are in. You have to work longer and harder for less each time you go back.

Custody, dorms, work camp, jail, & prison

Custody rooms = a private room with a private bathroom and shower. There is a bed a desk, and a sofa. It is like a basement hotel room that you can't leave.

Custody dorms = where one stays in a dorm but has the day free.

Work camp = where one stays in a dorm and works most or all of the day.

Jail = the inmates do work and reconditioning 3,000 hours a year under lock-up

Prison = the inmates do work or reconditioning 4,000 hours a year under lock-up

Factory camp is ideal for

Shoplifting
Vandalism
Petty assault
Drug license violations

Urban homeless and work camp

Work camp is the perfect penalty for nuisance criminals like those who repeatedly:

- 1/ Go to the toilet outside in a city.
- 2/ Use public property to be drunk or high in.
- 3/ Frighten multiple people with ravings, or actions.
- 4/ Steal things of trifling value.
- 5/ Dig in people's private garbage
- 6/ Burn things outside.
- 7/ Get into trouble for tent living in a city center.

Prison conditions

- 1/ All prisoners shall wear location monitor tech.
- 2/ All prisoners shall have AV of their cells and all prison locations they are in for their entire lock-up time.
- 3/ Prisoners shall be randomly blood tested for drugs, alcohol, and tobacco approximately once per year. Those found to have any of these in their system shall be moved and their sentence extended.
- 4/ There shall be no religious food in prison and all prisoners shall be required to eat pork bacon each day for breakfast or they will get no other food.
- 5/ No packaged foods, alcohol, tobacco or sweets shall be allowed in prison.
- 6/ There shall be no weight lifting or ball sports in prison.
- 7/ Prisoners shower in their cells.

What is the recidivism rate?

The studies use shorter periods of time like 4 to 10-years. The studies also don't include ex-convicts that learn from their prison time talks and don't get caught. So all the statistics on recidivism underestimate the true life-long recidivism numbers. Therefore the studies that show how say 64% of released prisoners get sent back, these are an underestimate and the true number is perhaps closer to 70% or perhaps 75%.

These numbers are of course for people trapped for years in a cell where they live a life of passivity and inactivity. If we habituate prisoners to long days of work. If we require that prisoners work outside the jail (but come right back after work) for the last 100 days, keeping all their money on a limited spending welfare card. If we give them a nest egg on this card from their years of 10% prison wages, they will certainly have a lower recidivism rate. Also, the prison and the half-way job should be at least 2,000km away from where they are from. And they should do their parole in this new place as a sort of new person.

Non-criminal jail

There should be special prisons for apparently good people who are first offenders, who have no criminal relations but who commit crimes under accidental, poorly judged, quasi-self-defense, or extreme situations, like say Kyle Rittenhouse.

Inmates will lie to get out early

Surprise! inmates will learn to be actors and say absolutely anything to get out of jail. So the I-have-truly-changed interviews where the inmates repent their past

life and say how much they have changed — These are a mostly a fantasy and a waste of time.

Good behavior early release should be robotic

How much lawyer and court time does the legal system waste on this thing that should be determined once and for all at the outset? So as part of sentencing, the court should select one of 4-10 standard good behavior matrixes, ABCDEFGHIJ. Then there are no parole hearings.

The penalty for murder-1

The convict works factory line work 12-hours a day, every day until they miss more than 10% of days in a year. Then they get executed. If they keep making mistakes and get fired from more than half of their jobs, they get executed. This applies immediately to first degree murder convictions with ample incontrovertible evidence. If the evidence is anything but incontrovertible, then the convict shall be allowed 10-years before execution may occur.

The Jail experience

Perhaps the juvenile courts should have the option to hand down 1, and 6 day tours. This is to demonstrate what all-waking-hours factory prison/ re-education life is about. It comes also perhaps with a 24-hour sample of dark solitary confinement.

Repeat offender multiplier

In addition to penalties for the current crime, repeat offenders might re-serve up to 50% of their prior sentences, all of them. Also, the multiplier might depend on the severity of the current crime.

Non-Citizens

Nations are natiois, places of birth

Why isn't the workers party saying

Less immigration and more jobs for workers?

The Democrats should oppose immigration because it undermines wages. But today, they demand even unchecked illegal immigration.

People will tolerate more immigration if it is properly vetted.

Unskilled workers must generally go back.

Welfare for illegals = buying constituents

Voting rights and immigrants

Citizen ID

All government issued photo IDs shall be required to indicate citizenship and immigration status. Also the ID

expires on the same day as the visa. If there is no citizenship and no visa, then the person cannot get a license.

Foreigners in our democracy

Non-citizens who vote or attend our protests shall spend 10-years in a work camp paying for their keep. If the foreigners are helping to organize or support a protest, then that shall be considered an act of espionage.

DMV voter registration

All voter registration must occur at a DMV office. The voter must have a 3D scan photo and give a thumbprint. The must also show proof of citizenship. All driver's licenses issued to non-citizens are revoked.

Voting and immigration

I would like to frame it as a 20 years to forever sort of thing. In some nations you might be able to vote in 20 years, but in others you may never be able to vote if you're an immigrant.

Citizenship qualification

The citizenship test

1/ When a foreigner becomes a naturalized voting citizen, it is supposed to mean that they are as good or better than the average person who grew up in our nation. It is not supposed to be easy for a foreigner to become a citizen and such a thing should be seen by all as a badge of honor. If more than 2/3 of qualifying immigrants are becoming full citizens, then the test must be made more difficult. If less than 1/3 of qualifying immigrants are becoming citizens, then the test must be made easier.

2/ The citizenship test shall have 2,000 potential questions, of which 200 shall be randomly selected for each person taking the test. No electronics, or study material, or notes, or dictionaries, or translators. A score of 80% shall be required on a multiple choice test with 5 choices for each question.

3/ Composition of the citizenship test:

20% Economics

20% How our democracy works

20% National values

20% Tactics of freedom's enemy

20% Vocabulary in the national language

People should be denied immigration when:

1/ They have not finished high school.

2/ They follow an unwelcome ideology.

3/ They are under-skilled to earn a living.

4/ They have a history of giving.

These are not refugees

Refugees are people fleeing for their life from natural disasters and war. The following groups should have no right to claim refugee status:

1) Ordinary criminals fleeing the law and wanting to make a new start.

2) Those fleeing economic hardship.

3) Those fleeing community persecution for being a sexual deviant, or being disabled, or being discriminated against.

Language & migration

When you migrate you must learn your new language and continue to progress in your new language (or Euemi) until you have mastered the language.

You take their customs

When you migrate, you must give the new ways primacy. You can only practice your old country's ways if there is no conflict in the two ways.

You are the guest

When you migrate, you must never push your hosts except when they are clearly and certainly wrong in a serious matter.

The number of children

This might be another criteria for deciding if illegals can stay. I think 6, 5, and probably even 4 kids represent an alien culture, and one that threatens to take over numerically in our democracy.

It isn't that bad

When people are sent back to where they emigrated from. It happens to people all the time.

Non citizens and crime

Non- citizens & pretrial release

1/When illegal aliens are accused of felonies and serious misdemeanors, there shall be no right of pre-trial release. This is based on the idea that these people have already evidenced an ability to slip past our nations borders and will probably slip back across the border again to avoid a long jail sentence if released.

2/ The bar for pre-trial release shall not be equal for non-citizens.

3/ The penalty for those caught trying to leave the nation to avoid its criminal justice system shall be a doubling, or tripling of the sentence.

5/ All foreigners that are arrested shall be checked for warrants and prior convictions in our nation and their own, as well as any nation they visited.

6/ Pre-trial release hearings may be held up to 10-days after arrest for legal aliens and after 30-days for illegal aliens.

Non-citizens and Mafia drugs

1/ There shall be no licenses issued for non-citizens to take methamphetamine, recreational opiates, or certain other recreational drugs.

2/ Foreigners shall not be allowed to consume more than 5 drinks a day on average over their trip, or more than 8 drinks in one day.

3/ Foreigners may not smoke more than one pack a day while they are in our nation.

Voter fraud and illegal aliens

Encouraging non-citizens to vote is a form of voter fraud. This is so even for lawmakers.

Dreamers policy articulated

Nearly everyone agrees that the hard working and college bound kids should stay and the lazy good for nothings should get the boot. Simple. The only problem is where the line goes. The Right wants to send more of the lazy problem kids back. The Left wants all the constituency it can get.

Multi citizenship people

The following rules shall apply to those who are citizens of our nation and have another citizenship

1/ They shall be considered foreigners for the purpose of voting in our nation's elections until they renounce all foreign citizenships.

2/ They shall not obtain any security clearance, or work in government or the military.

3/ Shall be treated as foreigners for the purpose of habeas corpus and bail laws.

4/ May be prevented from leaving the nation until they renounce one citizenship or the other.

Senate service and multiple nationalities

I see lots of people going from the richer parts of the world to the poor parts because they will have a better chance at making it into the Senate. These should still be able to keep their original citizenship, and have a partial secondary citizenship in the nation that they made Senator in. Even though they remain a citizen of the original country, they will still be treated as a citizen in the nation that adopted them as a Senator.

Double luxury taxation

Those who bring luxury goods across international borders may be subject to double luxury taxation or re-export bond upon entry. This does not apply to engagement and marriage rings weighing in combination less than 10g and having stones under 0.1g in total weight.

No money for illegal non-citizens

No government money should ever be spent on those who are in our country illegally, except for emergency life or death care.

International travel and visas

When you get your "State Department" passport app. You select up to 3 nations from a list for 2 hour's pay each.

The state department then notifies each nation that you will be visiting, and that you continue to maintain say your class C visitor status. This means that you have over "4-year's" wages in assets. (D = over 1-year, B = over 9-years, and A= over 16-years, whatever a year is). The state department also gives the applicant nation access to your background info page to see that you have no known criminal problems and such. After a while, the other nation sends you a visa/invitation via the app. Depending on your visitor class, you are governed by different visa guidelines.

Must declare all names

All immigration checkpoints shall ask all incoming persons to list all names they have used and all nations that they have been a citizen of and to declare under penalty of perjury that this is a complete list.

The slaves of Islam

These will all be charming model citizens for the rest of their lives. All of them will consider this to be a key part of their new struggle, a struggle plan that everyone can see will actually work and bring the struggle to a genuine conclusion.

Global citizens

I think the Main-Senators and Over-Senators of all nations, perhaps the top 0.4% of the population should generally be allowed to visit all nations without a visa. They may be excluded on a case by case basis if they cause trouble. Also, it is sort of irresponsible if they come from a poor nation and they leave after becoming a Main-Senator.

No illegals = no more housing bubble

It's not a concentration camp if you can leave and go home.

The lesson of Athens and Sparta

Look at where Athens is. It is just outside the "border" of the Peloponnese and Sparta. So this city fed on the prosperity of Sparta until it outgrew Sparta and ultimately dominated Sparta. The same thing is being angled for with the border towns of Mexico and we probably should stop this long-term threat to the land of the free if we are going to continue as a free nation.

Mexico entry permits

Perhaps we have a temporary system where people driving in from Mexico who are not US citizens must go to entry.state.gov and enter their data, their passenger's data, and their vehicle's data. Then they must pay the current entry fee. Then they are given a bar-code/QR-code PDF that they can print or display on a screen. Then

they show this to the agent upon crossing. Cars and trucks are charged at a higher rate because they take more time to inspect. Also, with this system, we can tax entries with money and easily phase out border crossings.

Illegal immigration must be stopped

1/ It is necessary for the achievement of a world-wide eutopia that we figure out how to optimally run a developed economy. The thing is we can't do this with hoards of illegals flooding in to take advantage of the free hand-outs.

2/ We reward hard work worldwide by rewarding it in our immigration policy. Let's only let hard working people come and work.

Drones and fat border buffers

Due to the advent of cheap drones and all jump devices, we must have a border buffer zone of some miles. We must also say that all small flying craft entering the nation may be fired on.

We can easily secure the border.

Two 8-ft tilt-up concrete walls and a mine field in between will do that. But can we do it a better way?

The cost of US border forces

There are currently about 17,000 people working to secure the US/Mexico border. If we build a wall and can cut 12,000 of them (@\$70,000/year each fully burdened with management costs, offices, vehicles, etc.), This comes to \$900-million per year for 3,145km. This is \$286,000 per kilometer, or \$286 per lineal meter of border that we are paying each year because we don't have a wall. And not only that, but these people are clearly not effective.

The advantages of buffer zones

- 1/ Jump drones are harder to use.
- 2/ No "tunneled" goods.
- 3/ They have to carry a ladder to the second wall.

Put the buffer away from people

If we move our border defenses some distance inside the US, then let's put them in the middle of

Mexico border crossings

1/ It shall be the official policy of the US government to phase out all the communities in Mexico directly on the US border. This shall be accomplished by:

- a/ Expensive crossing fees.
- b/ Dialing down and deleting the water we give them.
- c/ Requiring that people check in at a station 200-km or whatever distance immediately before entering the US.

2/ The immediate plan is to consolidate border crossings to nine points at: San Ysidro, Otay, Tecate, Mexicali, Yuma, Nogales, El Paso, Laredo, and McAllen. The other crossings like Del Rio shall be closed. The immediate plan also includes fees and long wait times that make commuting impossible.

3/ The eventual plan is to phase out trans border automobile traffic and to push all freight into 5 truck/train crossings (Nogales, El Paso, Laredo, Mc Allen, and Matamoros).

4/ Eventually the border will be closed to pedestrians and automobile traffic. Then everyone will either be required to fly or take the train to and from and from Mexico. And if they are entering or leaving the US, that must be from a point in Mexico that is more than 125-miles from the border like Chihuahua, Hermosillo, and Monterrey.

US-side maquiladora zone

The US/Mexico border Maquiladora areas will go in two locations, McAllen and El Paso:

1/ McAllen maquiladora zone: The southern parts of Texas, south Falcon state park (on Lago Falcon). There will be only two roads connecting this area with the north: US Hwy. 77 and US Hwy 281. Thus there are only two border crossings and two access points. The area between Falfurrias TX and Linn TX is 41 miles and this shall become a restricted area with all roads moving roughly east/west and connecting to the two very-well-secured highways, and all the existing north/south roads (paved or dirt) will be made inaccessible to vehicles by means of road-crossing trenches every ~1,000' and several east/west fences.

2/ El Paso maquiladora zone: The second US-side maquiladora zone will be all portions of Texas west of Fort Hancock Texas. This second zone will also include all portions of New Mexico state that are east of Fox peak and south of Texas' northern border at El Paso. Also, where the El Paso maquiladora zone is adjacent to the state of New Mexico, the southern 7-miles of New Mexico shall be included.

Border restricted areas

Because the border will be closed to automobiles and pedestrians, it will be easy to require registration and tracking devices on all vehicles entering this area. Thus everyone will have to walk.

The Rio Grande

The New Mexico River

1/ This river has 84% of the flow of the Nile and could provide enough water for about 84% of 141 million people, or about 118-million people at Egypt levels, and about half that at Southern California levels.

2/ The US state of New Mexico currently has 2-million people and El Paso has 1-million people. Ciudad Juarez has 1.5 million. That is 4.5-million people in total. So this

desert river's water is only being used at 3.8% and 6.3% of its potential.

3/ The Rio Grande has so much water that a portion can probably be diverted to eastern Arizona, (a route that is mostly downhill). This especially when we consider that Cochiti lake reservoir has an elevation of 1,702m and Elephant Butte reservoir has an elevation of 1,345m — plenty of fall for energy to power the water far into the desert.

4/ People should be living near the valuable desert waters of the Rio Grande on both sides of the border. It is better that the US border control of illegal immigrants operate in the unoccupied desert away from the Rio Grande. Better that the US have a 20 or 40 mile (or more) buffer zone in the desert to the north where vehicle entry is controlled and location monitored.

Parallel roads near the border

The vehicle access to the border zone should be via roads that are roughly parallel to the border. There are few roads perpendicular to the border with checkpoints that feed these border-parallel roads. This design give the border guards the ability to access the entire border zone quickly, but slows down people trying to get away from the border.

The border maze

1/ Which would you rather do? Walk 125m to the end of a fence and 125m back, or climb an 8' (2.4m) chain link fence with sharp wires from the chain link on top? Or maybe there is a strand of concertina wire (razor ribbon) on top. Everyone just goes around. It isn't worth the risk, and it also isn't really worth cutting the heavy gauge chain link with alarm sensors. And these fences are cheap, cheap cheap. And easy to repair. So let's have 250m long segments of fence with 10m gaps, one after another along the border. 250m of fence, 10m of gap, repeat. And let's layer these, offset, like courses of bricks, one after another. So to get from one segment to the next one must walk 1/2 of 250m. And let's position these (6m) apart, so nobody can bridge the tops and so the field sensors will still work. So in order to move 6m away from the border, one must walk 125m laterally. To walk 60m away from the border, one must walk 1.25km laterally. To walk 600m away from the border, one must walk 12.5km laterally. To walk 1.8km from the border one must walk 37.5km laterally.

2/ The compression of space-time in one dimension makes the area much easier to monitor and respond to.

3/ Maybe we break up the surface of the ground up so it is hard to walk on.

4/ We should probably have lots of bilingual signs up telling people that there is triple jail time for entering where there is damaged fence or holes are dug under the fence.

5/ At each end of each "maze" there is a much taller wall that cannot be scaled without equipment that must be carried through the maze.

6/ It is important to realize that that the most expensive part of border protection is the people. Even the expensive Trump wall pays itself back in less than a year in terms of ICE wages saved.

7/ There are two roads for border guards: one between the Trump wall and the maze and the other road on the inside the maze. These roads move parallel to the border and give no benefit to illegals.

8/ The maze isn't hard to figure out, but time consuming to get through.

Fence mazes the easy way

They are these hollow tube frames with 45° welded wire mesh that form panels that are maybe 20' and 8.6" tall.

They are all exactly the same and made in factories.

Much like a temporary construction fence, they mount to a round steel pipe driven or drilled/cemented into the ground. This has a T-hanger for a cap. So the panels hang on this T- hanger via a strap. And there is also another strap at the bottom of the sides to keep the bottom from rotating. It is all a bit flimsy because the panels are attached to the poles by means of 4 heavy plastic straps, heavy duty zip-ties essentially. So the panel is not touching the ground or anything metal. Thus the panels can be used as field detection sensors if someone goes near them. And we can put an animal wall around them, and birds move in particular ways. So not only are our border mazes slowing down the movement of illegal border crossers by 20-fold, but they are also reporting exact locations and numbers of people. Also, the areas under the fences might be sprayed with lightly ground cactus to deter digging and sliding.

El Centro California border protections

Between El Centro and Calexico there is about a 3-mile zone where there is no building. Here we erect a border wall and up to 16 fences between the fields. Then the only way in or out is via highway-111 and highway-7) south of Highway-8,

The 40-mile border zone

There shall be a 40-mile-wide double border zone with a double border along all portions of the Mexican border except for two parts

1/ The exception in the east is where the 40-mile border zone will be larger and include all portions south of Bluntzer Tx (Corpus Christi).

2/ The exception in the west is where the the 50-mile border zone will be smaller. In San Diego, the double border zone will be the portions south of the Otay river and Lower Otay lake. Then Otay Lakes road. Then Honey Springs road. Then Lyon's Valley road. Then Japatul Valley road. Then Highway 8 east.

A place for refugees

Maybe we should look at our border zone as another place where refugees can go for a few years. A safe place with work. Maybe this wasteland is where America's high-paying, hard-working, work-and-leave foreign-worker factory-towns go. Maybe we let people come here from other parts of the world to work under contract, like Singapore does.

Unskilled worker programs

We share our ways most by sending people back. One 50-year worker shares little of America with his countrymen. Ten 5-year guest workers will allow us to touch so many more foreigners. And maybe the best is to touch 50 times as many foreigners with 1-year guest worker programs.

Just imagine a world where the people from the poorest nations could participate in a worldwide guest worker program, becoming cosmopolitan, and then going back home and help develop their home land.

Mexico doesn't care about El Norte

The Mexicans regard their northern border as a sort of Detroit. And the whole narco trafficking thing, while good for the economy is, causing way too many murders. And that is obviously a thing of the border. So Mexico has problems with El Norte and mostly it would welcome the imposition of solutions that would work.

Mexico is made of glass in matters of border security

All the US has to do is throttle either remittances or border traffic. So whatever way the US wants to remake the border and the relatively uninhabited desert parts of Mexico, that is how it will be if the US truly decides.

The long term US border plan

1/ Close the border to traffic that is not rail based.

2/ Only allow people to come into the US if they started their trip more than 200 miles from the border.

3/ Eliminate all the border towns.

4/ Make sure that all Mexican roads within 200 miles of the border run parallel to the border except for the feeder roads which all have 24 hour roadblocks.

A corrupt Supreme Court:

The 14th amendment totally misconstrued

[The US Civil War ended in April-1865, and the 14th amendment was passed in June-1866. Reading the 14th amendment, one clearly sees a nation trying to force the defeated South give full rights to former slaves, a hugely important thing for America, a thing that that took over a century to actually get underway

The 14th Amendment is all about the wake of the Civil War and only about the Civil War:

Section 1: Makes the former slaves citizens.

Section 2: Gives the vote to former slaves.

Section 3: Bans rebels (Confederate people) from serving in government.

Section 4: Guarantees the Union debt and defaults on the Confederate debt.

Now Section 1 of the 14th amendment says:]

"All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws."

[So here is an amendment was totally about the end of slavery, an amendment that had absolutely nothing to do with the children of illegal immigrants.]

Equal protection

Equal protection rules shall not apply in cases of non-citizens, border zones, protectorates and extra-territorially with non-citizens.

Ending the remainder of the foreign slave culture

Slave talk = slave culture?

That "you-is", "i-is", "we-is" sort of black language was how slaves were taught English. It is a simplified slave-speak that the owners used on their new African slaves that spoke various languages on arrival. After emancipation, the slave language remained and slave culture remained among many. And it remains today still, as "black speak" in its various mutations. Here I would suggest are cultural and mental pathways of slavery and resistance to domination. So, I ask: Is this a heritage that should be preserved, or is it a heritage that should be extensively altered?

Slave talk

Evil spirit can be killed by mirrors and the look-at-yourself, self-awareness they imply. Another way to kill an evil spirit

is to call it by its true name. This is another way to impart look-at-yourself, self-awareness. So maybe we should use the term "Slave talk" instead of black talk.

BRV = Black resistance virus

The African-American slaves didn't even have to tell each other to resist their owners. And after that, when they were "free", but poor and heavily discriminated-against, they naturally resisted the dominant culture and "the man". You need to put this aside now, it is getting in the way of your equality.

No black only colleges

Preventing international abductions

Sexual consent and rape

Registered sex offenders

Level 1: Groping

Level 2: Date rapists

Level 3: True rapists

Unless they are repeat offenders, only the last group may be required to live in an isolated community.

Touching your kid's friends

Step-kids, girlfriend's kids, whatever. If the friend is under 21, then the parent role person is not supposed to touch the kid ever, in any way. The same with teachers. They are never supposed to touch the kids unless it is to break up a fight between kids, or to keep the kids from harming themselves.

A gradation for sex crimes

I just read about the Perilloux case where a judge was sentenced to 14 years in prison for giving two of his daughter's 14-year old friends back rubs, and rubbing sunscreen on the back of another of her friends. The

penalty seems excessive. This man should lose his judgeship and maybe do some community service. That is enough.

Gang rape or consensual sex?

When multiple people take turns or simultaneously have sex with one person who is not a registered prostitute, or advertised swinger, consent must be explicit, and the burden of proof shall be on the gang to provide proof of consent if accused. To prevent issues of coerced consent, the consent must be at least 48 hours in advance. Very convincing sober-looking AV statements will work too, but these are perhaps subject to claims of coercion if they are not totally believable. Modified:

"In order for sexual contact to be considered non-consensual, generally one of the following must apply:
a/ The accuser was injured, or under threat of injury.
b/ The accuser was prevented from getting away.
c/ The accuser was incapacitated or not conscious.
d/ The accuser was a minor, or not legally competent.
e/ The accuser was touched in a way that prevented them from expressing disapproval in time to prevent the touching.
f/ The accused disguised their gender.

R'96.10

Modified:

If an accuser in a sex crime case voluntarily goes to the accused, or meets with the accused, or initiates communication, or engages in communication with the accused after leaving the crime scene, but before filing charges, it shall be deemed consensual sex. This rule shall not apply where contact is unavoidable however, the accuser must make every attempt to avoid and get away from the accused, or they will lose their right to claim non-consensual sex.

1/ Certainly this behavior was not considered assault or rape in vastly more prudish 1949 America. Now people are asking if this is criminal behavior given the #MeToo climate.

2/ Is Ricardo Montalban using force? He is certainly holding the woman 10 times at 0:29, 0:33, 0:35, 1:18, 1:32, 1:37, 1:41, 1:54, 2:22, and 2:26. But he is gently holding her, and he is not using his superior male strength to restrain her. In fact, she is able to easily get away every time.

3/ This behavior was a part of the courtship in the film, because the woman eventually stopped objecting.

4/ In this film, no did not mean no, and the woman eventually gave in.

5/ If we look at the animal kingdom (pigeons, dogs, cats, etc.) no often mean try again, as we see here. In fact this clip is quite reminiscent of the way pigeons mate.

6/ In many mating situations, no does not always mean no.

7/ To my mind, this clip is valuable because it is pretty close to the edge, but it is definitely not sexual assault for people who willingly went to a private place together.

8/ When did society change the rules? What notice did it give that the rules have changed? What are the new rules exactly?

9/ Someone should make a show where there are a few 3-minute examples of what is definitely sexual assault, and a few 3-minute examples of what is definitely not sexual assault.

10/ When does aggressive begging become robbery under threat of force? Where do we draw the line?

Where do we draw the line with regard to persuading for sex vs. sexual assault.

11/ "Say what's in this drink" is sarcastic, and a reference to liquor (of course) being added to the soda or canned juice. It was not about date rape drugs. It was about an already-interested seldom-drinker given a 2X-4X drink in a tall glass of juice.

12/ Her lines: "well, maybe a half a drink more" and "maybe just a cigarette more" do not fit with assault. In fact, it says that all the prior behavior was acceptable to her and not over the line.

The rules of saying no to sex

1/ If you have willingly engaged in kissing or embracing, or undressing, you must make a genuine effort to get up and walk away if you want to stop. As far as your legal protections are concerned, it is not enough to simply say no once you have started in these ways, especially if you have gone off to a private place with someone.

2/ If you say "stop" or "no" or a similar word and later willingly engage in kissing or holding, or caressing, or nudity, it cancels all previous "stops" and "nos" and similar words.

Bars and ID verification

An alcohol licensing system will record every bar customer's name. This will make it easy to identify and exclude problematic drinkers as well as sexual predators.

Prostitution

8/ Recorder video is required inside all massage businesses.

Pornography

Porn categories

level-1 porn: no clear picture of the genitals other than public hair.

level-2 porn: nude people with nobody else and no other people or touching genitals.

level-3 porn: heterosexual sex involving no more than two people, both documented to be over age 21. There is no contact with the anus in this category.

level-4porn: all other legal porn.

level-5porn: illegal subject matter such as rape, bondage, violence, coercion, sex with animals, incest, etc.

R'96.32

Added:

Regarding pornography

1/ Government shall tolerate pornography because it is impractical to get rid of. However, there shall be no copyrights for media depicting the skin between mid-thigh and the armpits.

2/ To reduce exploitation, all sexual pornography must to be submitted to a country recorder and all actors licensed and registered. It shall be a crime to distribute unregistered porn. Registered porn will never get the possessor into trouble with the law, but unregistered porn might.

3/ All pornography feeds shall be on their own pornography TLDs depending on the porn level. All gay porn and kinky porn feeds must be on their own special TLDs. Non-pornographic search engine and commercial web directory shall not link to any porn TLDs, nor shall they display any porn images. There shall be a clear distinction between the porn internet and the non-porn internet. Porn TLDs from other nations may not be displayed in our nation.

4/ Government shall not approve porn that involves real, simulated, or depicted:

a/ Sex with minors under age 21.

b/ Rape or resisted sex, sex under threat or extortion, coerced sex, and sex under blackmail. Also sex with fearful or improper facial expressions and sex where weapons are present.

c/ Lack of consent, sleeping, or seemingly drugged actors.

d/ Bondage, restraint, domination, degradation, or imprisonment.

e/ Violent sex with beatings, whippings, blood, bruises, beating marks, or infliction of pain, real or simulated.

- f/ Sex with animals.
- g/ Incest.
- h/ Secret recordings.
- i/ Sex for money or other compensation.
- j/ Sex with people who have had surgical alterations including implants.
- k/ Sex with feces, urine, vomit, gagging, feet or shoes.
- 4/ It shall be a sex crime to divert people to porn websites. This crime shall have double penalties when children are intentionally targeted, or gay, or violent, or transexual media is displayed by means of traffic diversion.
- 5/ It shall be a crime to put another person's face on pornographic media.

Registered porn

- 1/ Some people want to be porn stars and others want to look at them. Who are we to say that they should not do this. This is to be treated like gay sex and other forms of onanism by society. It is neither encouraged or prohibited.
- 2/ All porn actors be licensed by a recorder's office. They must go alone and verify identity, age and that they have completed the 4-hour online porn licensing course. They are given a mental competency test to assure an IQ over 80 the recorder's office and issued a license.
- 3/ All actors must go alone to a recorder's office and sign off that they allow their image to be published. Public Theft RFID recording

A county manages our ID/ address/ signature/ financial information. Then it produces a unique single use first name + alphanumeric instead of the real customer data. So the hotel and airline staff don't know you by name. And the booking company doesn't know your real name unless you give it to them.

Surveillance and ID verification where

- 1/ The hallways and all main streets and commercial areas all have overlap video recorded...backup buffered by the recorder as a public utility paid by property taxes.
- 2/ People have cameras by their units that may or may not be publicly backup buffered.
- 3/ The stations, their nearby streets, the trains, are all on overlapping video.
- 4/ People can use location-trackers when they do something dangerous.

5/ The outer woods, the booths, the changing rooms, the public bathrooms and the private properties may not be recorded by government without a court order. These places shall also be checked by the local government and kept free of private recording devices.

6/ Residential communities should not only be allowed to verify ID for everyone entering the community, they should also be able to rely on the recorder's office as instant ID verifier, and list app keeper.

Vanity phone numbers

Those in the law and healthcare industry shall be prohibited from using so called vanity numbers that are easy to remember. Also, no phone number may:

- 1/ End in 00.

Search engines, paywalls and logins

- 1/ Paywalled and login-pages may not be returned by any search engine.
- 2/ The first/top word on all paywall websites must say paywall and the search engine must display this.
- 3/ The first/top text on all login websites must say login and the search engine must display this.
- 4/ No national or international news outlets may have a paywall for media less than 5-years old.

Pop up web ads

These should pay web ad tax as if they are 2 full pages in size.

Suspension of social media accounts

This may only be upon violation of the law and a court hearing in the jurisdiction of the account holder. The user must post a day's pay to arbitrate. If they win, they get 2 day's pay back. The arbitration takes up to 1 hour and takes place via video call.

Social media priority algorithms

- 1/ These must all be open source and well explained.
- 2/ They must be comprehensible by the Senate.
- 3/ They must be published two tenths in advance.

User data and espionage

Everyone working in a public infotech center or recorder's office Shall have security clearance, and there should be no foreign born people here ever. Those found passing user data are subject to espionage charges

Healthcare and ubiquitization

1/ To the extent we ubiquitize drugs, we can give them everyone who needs the drug. And we can do this for the same cost as today when we only give it to some of the people.

2/ If we scale our equipment manufacturing lines, we can outfit all the hospitals and more with all the ubiquitized equipment for essentially the same amount of money as only outfitting some of the hospitals.

3/ We are not getting any benefit from using a market economy for unique patented drugs. There simply is no free market here. Why are we pretending there is a free market? Maybe we should completely detach the market value from the X-prize award amounts. Then we just keep increasing the X-prizes slowly each year for the problems that have not yet been solved.

Computer information

In general, the right of the people to anonymity shall trump the right of computer companies to gather data about users. When in doubt, the rights of the people to anonymity shall prevail.

The ultimate nanny state

We make people carry pedometers, and charge them each day when they are torpid. So maybe each day that geezer and wife don't leave the house they get a "\$4 daily HCAS charge" on their credit card for failing to move by the required daily minimum amount.

Government should supply all citizen with the following services free of charge and almost entirely free of advertising due to their low cost:

- 1) Free internet via municipal wifi.
- 2) two email accounts.
- 3) A facebook page (with 2 ads per hour.)
- 4) A blogging and downloads page.
- 5) A word processing and written report maker.
- 8) A spreadsheet program.
- 9) A photo editor.
- 9) A 2D and 3D drafting program.
- 10) A twitter account.

Ubiq first mover advantage

When IP gets ubiquitized, the developing company will still have a team already assembled.

Ubiq electronics

- 1) We should have standard versions of: desktop computer, and tablets in 6-sizes.
- 2) All designs are open source. with open publically rewarded commentary.
- 3) Bugs reported (no matter how small) get some official ubiq status and money.

4) All software is open source and new applications in the IP period gets their fair sliver of the world IP budget, call it X-cents per user hour.

100 billion prices under \$1

What if every product and every transaction had a unique price that was to the billionth of a cent. Then we can easily search out the payment forensics. Theft becomes much harder. Auditing becomes many times more effective. And it rounds at the bank level for privacy.

Mesh networks and peer to peer network

These must not be prohibited by government

Twitter & Facebook

Should be open protocols not monopolies

Uncensored twitter and facebook

The twittering and facebook communication functions should be in the form of a 2-part software package loaded on independent servers to create an ad-hoc network. These are all independently operated at both the page hosting and aggregation levels. But they use the same data protocols. This way, the users can choose which aggregators they want to use. They can also choose multiple parallel aggregators.

Why does it take 3-years to get Google on trial for anti-trust?

Google IS evil

- 1/ Google may only be slightly evil, but it is evil and parasitic for absolutely everyone on earth.
- 2/ It isn't right to have this for-profit entity extracting money from our baby businesses so that they may find their markets.
- 3/ It isn't right to let middlemen aggregators engage in a corrupt bidding war with their principals for top billing on Google? Surely this just increases waste and drives prices up for nothing.
- 4/ Absolutely the same thing can be said about Facebook.
- 5/ If we condemned Google and Facebook, and ran the advertising for the benefit of the nation small industry business, We would have a much better small business environment (and national economy). We would propagate any more small businesses that will turn into large businesses and benefit the people. The proper sharing of information about new businesses and new products is one of the most important things in a capitalist system. The fees that Facebook and Google charge are not designed to increase this, but to go in exactly the opposite direction and stifle new business so that the old businesses of Ishtar will stay as robust as possible for as long as possible. Thus we need to go in the opposite direction and offer Facebook/Google alternates.

Search engines rules

- 1/ Search engines are required to display the main url for each company first at top of their listing
- 2/ Search engines shall not be allowed to display third party aggregators on their first page, or the first 20 listings.
- 3/ All ads must go in a separate column to the right that is no bigger than the right most 1/4 of the page.
- 4/ The jump to page numbers are shown at the bottom of the search return pages as:
"1 3 5 10 15 20 40 60 80 100 (Page#____)"
- 5/ The total number of search result hits must be shown for all search terms.

Social media rules

- 1/ Dominant platforms shall be held to different rules than small ones.
- 2/ Platforms that sell advertising shall be held to different rules than those who don't.
- 3/ Platforms with fake account problems must verify ID.
- 4/ All platforms must allow for total removal/retraction of all comments from the platform.
- 5/ No fictional citizen whether for profit or not for profit shall ever judge or punish a real human for exercising their right of free speech, no matter how awful.
- 6/ All sites shall support both notified and quiet blocking for their users.
- 7/ Targeted advertising belongs mostly to the people, not social media outlets.

Senate Facebook

- 1/ If government ran the dominant facebook/ person directory, then Senate status and stigma could be there for all to see.
- 2/ There would be no need for ads, but we might have 2 properly targeted ads per hour so the government's facebook makes money. And none will ever be repeated, unless we go to the ad log page.
- 3/ Half the ads can be EDU or PSA message like: dream big, work hard, be honest. Learn something new. Don't be a bum, etc.
- 4/ It really means something when you log in with your facebook. Perhaps this has 2 or even 5 levels of ID/ information sharing with the site we are identifying with
- 5/ The person's verified Senate, EDU, and ubiq achievements are listed.

Facebook and Amazon are posers

There is no real tech innovation that came from either company. These companies are therefore posers, pretending to be innovators to hide how they are actually monopolists. Google at least brought forth some innovation about 15-20 years ago.

Always on listening devices

- 1/ These must have a physical switch to the microphone.
- 2/ They should never be required except by employers at work.

The easiest home sharing tweak

It is to eliminate the parties and noisy users by law.

1/ We need to have different rules for them because they don't have to live there.

2/ The noise rules are enforced by government, which will evict the over-night sharing renters on the spot for egregious violations such as large parties and damage to premises.

Helping the people to share

If we really want to get serious about encouraging sharing in our economy, then perhaps government should subsidize it through providing the following low cost services for free, or nearly free:

Arbitration of sharing disputes

Documentation platform

Initial walk-through video backup

Transaction processing

ID and profile verification

De-platforming problem users

Police take responsibility for noisy users or abusive rental users.

UNDO

There should be a text interface of what you are undoing in order.

More Firefox buttons

It could easily have 14 or 18 buttons in place of the current 5 buttons. Several configurable buttons like:

1/ Turn off host-generated refresh.

2/ Cookies menu.

3/ Delete all temp info.

4/ safe mode.

Every bar must be hide-able

1) All command bars should hide automatically on all applications and all operating systems. These should all disappear from view until we mouse/finger over towards, gesture, or otherwise head to where the command bars are.

2) No website or application can have any bar that cannot be scrolled away and closed permanently

3) All operating systems and websites can use no more than the height of 2.4 lines of text for open "window tops". This is enough for 2.0 lines of text display and borders.

4) Browser text insertion bars shall be no more than 1.2 lines of text in height.

5) All browsers should have a "show hidden menus" command. This opens all the hidden menu bars.

Clipboard to file collect

Operating systems should have this setting where text can be selected and copied to a file clipboard without the additional step of pasting. You just do command-c, command-c over and over and the cuttings are all collected to a certain file, perhaps for that day or that week, or month, whatever. There is another version where the cuttings go in a spreadsheet

When you close a document

It should automatically appear just as you left it when you saved and closed. Same window size and location, same appearance, everything.

Default no images mode on browsers

When images are off, there is a scaled image icon with a description. If you touch the image it loads. This makes it easier to keep images off.

Variable speed select by finger roll

You roll your finger a bit left to go left slowly, you roll your finger far to the right to go right fast.

Add voice notes to recent calls

We should be able to append notes to calls and then to review our own voice notes either in audio or in transcription.

Apple text edit flaw

Auto link should always go off when in text editing mode.

Transparent desktop

Ok, so we can't have translucent iPads. But we should be able to emulate them in the operating system. Then we can run the desktop better on vizers for augmented reality mode. Then we merge faces into construct footage, maybe a simulated conference room on the 77th floor, or an eternal Thira sunset, or whatever.

Presentation pointer & comet

Wouldn't it be nice if MAC OS had a giant cursor for presentations... one that turned into a colored highlight "comet trail" when you laid your finger flat on the track pad. So you could wipe your finger back-and-forth under a line of text to create this quick-fade highlighter. Or draw a circular around some thing to draw attention to it. The fade rate is adjustable as is width, length, and color.

>>>

Zoom cursor

When you put your fingerprint down and hold it, the screen zooms in slowly. When you roll your finger to the tip, a cursor or insertion bar appears depending on the app. If you lift your finger the cursor then remains in place for a single or double tap in another location to either side. If it is an insertion bar, simply lift to place. To select

text, roll contact finger right or left. A little bit and it selects one letter every second. More finger roll selects whole words. More selection is by dragging the selection box.

Phone alert LED color

Next to where the back cameras go there should be two or three variable color alert LEDs, so people can tell their alerts visually by color: Maybe Green is work, Blue is male, pink is female, red is spouse, dark blue is X, purple is Y, orange is Z. If the light is dim, it is not important, the brightness is high it is important it is. Urgent is flashing with quiet alert tone. Super urgent is flashing fast with loud super urgent interrupt tone. And why can't we authorize certain people to override our silent mode with a code?

Permission based email

Browsers should have this: minimal, medium, full, financial, login, whatever. We go to a site and it wants our ID. And with a level-1, they get your email. But if we don't respond to their mail, then can't contact us again.

No tracking of web users between sites

Once we have an attention payment system, why don't we just outlaw cross-site cookies?

We might restrict resolution on devices to reduce bandwidth

Uninstall-able software

Companies that distribute un-installable software and software that is intentionally difficult to un-install shall be liable for the costs that people incur. They may also be shut down.

Batteries

1/ Devices should have a battery temp indicator like with a car engine. They should also have a yellow warning light when they are getting close or heating fast.

2/ When you plug in your charger a window pops up asking you to press a button indicating for how long you expect to be charging for.

IOS notes

1/ People need to be able to search all notes, instead of individual ones.

2/ Notes needs to be more like a true word processor. Also, it should have low and high power mode.

Swipe to alternate desktop

4-vertical fingers swiping right opens an alternate desktop to the right. Over all, 8 alternate desktops can be swiped to via 2 such steps.

Corner bumpers

Put tiny screws holes in the corner of the iPhone iPad so people can screw on dumb-bell shaped rubber corner bumpers. These can also be used for a mounting bezel, something the iPads could use.

Bezel cams

The real 3rd camera isn't on the front or the back of your phone, it is on the bezel. This camera points straight ahead when you have your phone sloped for viewing at 45°. This is the camera people use to record other people behaving badly.

Delete cache button

All browsers should have a clear temporary data button on the top bar given how much we use this function.

Camera buttons

There should be a touch image anywhere to shoot configuration. Tapping the center of the screen will produce less image shake

Website refresh off buttons

All browsers shall have a button to turn off website generated refreshes. This can be turned on when the user goes offline.

Browser reloads

No browser may clear pages once loaded because the connection has been lost or a website has said "reload page". All browsers must bring back all closed pages until the clear/ full-logout button is clicked by the user.

Imagemap

Videomap

This is where you upload photos and videos of places so people can look at that place remotely. Every image has GPS coordinates and an angle of view. This is mostly for landscapes and virtual travel. It is sort of like a google images, but it is more location specific. So you go to a map of say Bagan in Burma. Then you have these rolodexes of images from a certain spot looking in a certain direction. And there is also a video function, so you can go with countless people walking through the center of wherever.

Interface systems IP dies quickly

These rights die in maybe 5-9 years. Otherwise, this is a thing that is hindering the advancement of software development.

Unrelated ideas

When people working as hired inventors in one product/ area come up with unrelated ideas, their employer should not be able to have any claim to that invention, even if a document is signed. A great many more good people will work in hired innovation if we do this. Related ideas

belong to the employer, but unrelated ideas and different industry uses belong to the discoverers.

Internet rules

1/ Government shall not require people to acknowledge anything when visiting a website, as this is an opportunity for inserting malicious code.

2/ No internet browser shall be integrated with an operating system. All such combinations must cease upgrading as unified things.

Swiping up from the IOS delete button

This brings up a bunch of different selection and delete tools/ buttons, like an undo button, a redo button, a save all delete activity to document button.

IOS Voice + text

When we use voice text on our phones, the keyboard should be available to insert punctuation and special characters and to erase text without turning the voice part off and on.

Selection assisted voice transcription

When the voice control on your phone is uncertain of its choice for what you just said, that part should appear popped above the text in a box with a number of permutations that the computer wants to suggest you touch the one that's right, then you touch the next one in the string of text.

ID verification and electric cash

There are 3 parties: User, Business, and Recorder. How it works is that your phone establishes a secure link with the county and then asks for a temporary ID which it gives to the Business. Then the business gets the user's photo and a number, but no personal info except your self-chosen user name.

Phones

1/ Because of the ubiq system, all phones will have the same state of the art features. Or it won't be IP that holds them back at least.

2/ Most good software will be open source and funded by tax money and Ubiq rewards. It will also be free for individuals to use.

3/ Everyone can open every file using every type of software on all devices.

4/ There will be one standard interface, not two.

5/ The Sub-senate runs tech support boards for eliminating bugs.

Holo gesturing

1/ There really should be one set of gestures for all systems.

2/ holding your hands at 45 degrees around an imaginary balloon being inflated/deflated is screen zoom, for example.

3/ hands flash rotated inward is right-click, hands flash rotated out is left-click.

4/ Move screen with index finger.

5/ Rotate screen with thumb and index finger.

6/ Thor calling his hammer gesture = tools and settings.

Auto rotate on phones

It would work better if it was oriented to the image of the user rather than gravity. Also, putting your phone down while video calling

This automatically flips the view to the ceiling instead of the counter top.

Stupid emojis

Why can't I turn off emojis on my phone?

Double clicking the arrow-box should bring up the search engine homepage.

Communication PIN numbers

All phone numbers and email addresses should allow 4-digit passwords (that account holders can change at will).

This code (if the function is on) is the only way to make the recipients phone ring or inbox get the email.

Otherwise the communication is considered spam and is sent to the trash. The pin might also be required for text messages.

Text message folders

Why can't we have email like folders for cloning text messages to?: Inbox, spam, work, outbox, archive, save for 6-months, etc.

What if we never had to watch the same commercial twice?

Ratings systems

Let's tweak our review and rating systems so they have top bullet comments like:

1/ "lobby was full of dust because they're remodeling three units in that building." 27likes

2/ "Noisy area" 19 likes

3/ "Mosquitos coming from shower drain" 9 likes.

This type of commentary is both more useful because it is easier to grasp and also less subject to censorship.

Simulated reality

We will walk around and sit in these simulated reality situations where we can look down and wiggle our fingers with no perceptible lag. We will see people melded onto other people's faces perfectly. It will be like a video meeting. But it will be in some fantasy construct.

The VR view

We are either looking at the ground, looking out, or looking up. A proper VR system have at least these three modes.

Mankiller games & media

These should be stopped except in the context of training to defend against those trying to impose their will through arms. There should not be these video games where people go and kill other people except as national defenders.

Where does media violence shape minds the most?

Is it in our smartest people, or our dumbest?

HVDS = human video double-check shipping

This is where the robotic system fetches the goods and passes them by video cameras and remote arms where humans double check shipments remotely. It's sort of an intermediary step on the path to total automation.

If I ran a credit card company

I would issue 3cm x 9cm credit cards instead of the current size 5cm x 8.5cm. I would issue two cards per account, a clean card with a high limit, and a solid color one with a low limit and limited liability. I would also encourage people to have multiple accounts with my credit card company. I would send out both cards with a custom wallet that has special slots for these cards which are 1/2 to 1/3 quarter as slim, because the cards go into 3 or 4 pockets on the same sheet in one's wallet.

We use nano-sim cards

What about credit cards and IDs?

And if we put our ID on a similar sized card, and eliminate money. Then perhaps some people will want three cards on the back of their phone. ID and two physical credit cards, super thin cards ... and no wallet. Maybe also on the unused corner of the phone back, there is room for a key or two.

The credit card system

When you give your number to a vendor, your picture, but not your name comes up on the government's payment screen. So the credit card is just a code to access an account.

Log-in real world entry

What if people had to login to enter a physical bank or a convenience store between 11pm and 6:00 am? What if you had to present your ID to get in through a bank's double doors? What if the banks knew the names of the bank robbers before they entered the bank? How do people then shoplift or do holdups?

Things that will now be considered hacking

1/ Websites that send visitors to other websites without them clicking their permission.

2/ Emails that send any information at all about the recipient to the sender.

3/ Data that remains on a browser after the cache is cleared

4/ Using any fingerprint scripts

Ghosting

All actions by all social websites must be declared. There shall be no secret ghosting.

Defense & War

America and Europe are big prizes

Among billions of starving people.

This should be a 60-day or 90-day meme.

We help where we can

Freedom should be intolerant of tyranny and Mafia rule. Freedom should project power against injustice, where practical. Carrier-based air support to war torn areas of Africa is a prime example of a thing that freedom can do against tyranny that is very practical and very simple.

Arming war zones

In war torn poor areas, maybe the UM should give each Nome 2-to-50 bolt action rifles. These are handed-out by the Sub-Senators who themselves may not carry long guns while in office, except when under fire. Any force able to confront this sort of militia will be vulnerable to air strikes from the Africa corps. Thus the warlords will hopefully be eliminated.

Infantry = cannon fodder

2/ This practice favors national defenders and real armies with their own reliable supply lines.

3/ This practice cancels out the cheap AK-47 network effect, and serves to partly ruin the weapon.

4/ It is incredibly cheap to kill a portion of the bad guys everywhere.

5/ We don't even have to actually do this. Mere talk of the idea is corrosive to warlordism.

Sabotaged weapon replicas

The US should introduce all sorts of perfect replicas into the weapons supply chain.

1) Perfect replica RPG rounds that detonate instead of firing.

2) Ammo that tends to kill the people who fire it and breathe the smoke.

3) AK-47 clips that are radioactive and poison the people wearing them every day.

4) Once word gets out, we should make a big thing of this in the media.

Arms/vehicles with missile beacons

Then air support (mere Super Tucanos) fly with beacon-seeking cluster munitions. Maybe the beacon only comes on when prompted.

Military medals

Existing medals will not be recalled, but no new medals should be issued.

Tank hunting RC drone car mines

Imagine a cross between a Hershey's kiss and a shot put but it weighs maybe 40kg. This is placed on a 4-wheel video-operated RC drone car weighing maybe 40KG.

2/ Is the government menacing people in some way? If so, it is a tyranny.

3/ Were there elections, real elections? If not, it is a tyranny.

Stop warning tyrants before we attack

Otherwise they will just do it until we point our guns at them.

Zero tolerance of tyranny

We as free men want to drive tyranny from the entire world. We want to liberate the entire world. Therefore, we will accept nothing by democracy on earth.

Democracy has the strength of the police

Plasma cutter drone submarines
